SUMMON

WHEREAS, in connection with the **APIC-No. 933/2025**, your personal appearance is required before the Commission on **21st July, 2026 at 02:30 PM**. The 1st hearing held on **7th May 2026**. The Appellants Shri Palen Laa and Buli Bhai are present during the hearing before the Commission.

The PIO-cum-Project Director, DRDA, Raga, Kamle District, Govt. of Arunachal Pradesh is absent without reporting the reason for his absence to the Commission despite WT message sent to him from the Registrar of the Arunachal Pradesh Information Commission (APIC) on 16.02.2026 to be present today for the hearing.

Heard the Appellants;

The Appellants stated that despite the order from the PIO-cum-Dy. Director Rural Development to provide complete information to the Appellants on 03.02.2026, the PIO has not yet provided them any information, and therefore, this Second Appeal filed before the APIC.

In the absence of the PIO the statements of the Appellants could not be cross verified and so the Commission decided for a next hearing.

Under the above circumstances the Commission hereby pass the below orders;

- 1) Send Summons to the PIO-cum-Project Director, DRDA, Raga, Kamle District, Govt. of Arunachal Pradesh to be present in the next date of hearing without fail, failing which necessary action as provided under RTI, Act, 2005 will be initiated against the PIO.
- 2) The Appellants to be present in the next date of hearing without fail, failing which this appeal will be heard and determined ex-parte.

- 3) Notice for the next date of hearing need not be sent to the Appellant as they are present in the Court today.

The Commission hereby orders;

The next date of hearing be fixed on 21st day of July' 2026 at 2:30 PM (Evening).
