An Appeal Case U/S 19(3) of RTI Act, 2005

Case No. APIC- 369/2025.

SUMMONS

This is an appeal under Section 19(3) of RTI Act, 2005 received from Shri Bamang Pacho for non-furnishing of below mentioned information by the PIO, o/o the E.E (PWD), Sangram Division, Kurung Kumey District Arunachal Pradesh as sought for by him under section 6(1) (Form-A) of RTI Act, 2005 vide his application dated 06.02.2025.

A) Particulars of the Information: Under Budget Estimate (BE) 2023-2024.

1. c/o Community play ground at Govt. Pry. School Sigriang under Parsi-Parlo Circle;
2. c/o Community play ground at Sigriang Village under Parsi-Parlo Circle;
3. c/o Community play ground at Subu Village under Parsi-Parlo Circle;
4. Site Development with RCC retaining wall at Parsi Parlo general ground, Kurung Kumey District;
5. c/o guest house at Damin;
6. c/o renovation and maintenance of Govt. Residential School Kopila under Damin Circle;
7. Procurement of furniture and kitchen item at Parsi-Parlo IB and
8. Installation of Tourist recreation at Kucho bridge point under Paniasang circle.

B) Details of Information required:

- i. Work order by particular name/firm.
- ii. MB Note
- iii. DPR
- iv. Cheque counter foil particular by name;
- v. LOC*
- vi. 3 times geo tagged photo
- vii. Payment details
- viii. Details of credit amount
- ix. Details of account number in which amount credited
- x. Bank & Branch Name which amount credited from concerned department
- xi. Completion Certificate.

C) Period for which information asked for: 2023-2024

Brief facts emerging from the appeal:

Records emerging from the appeal disclose that the Appellant, Shri Bamang Pacho had requested the PIO for the aforementioned information / documents but failed to obtain the same which prompted him to appeal before the Chief Engineer (PWD), Central Zone, Govt. of Arunachal Pradesh, Itanagar as the First Appellate Authority (F.A.A) under Section 19 (1) of the RTI Act vide his Appeal Memo dated 01.04.2025

Records further reveal that the First Appellate Authority-cum-Chief Engineer, Central Zone-A, PWD, AP, Itanagar conducted a hearing on 25th April, 2025 wherein the appellant Shri Bamang Pacho was present but the Respondent PIO was absent. The FAA upon hearing the appellant, had passed the following order :

"After hearing the case, it was found that the PIO has failed to reply/furnish the information as sought by the appellant in his RTI Form A received dated 22.02.2025 via post within the stipulated time period.

Therefore, the respondent PIO was directed to furnish all documents except information sought at Sl. No. iv i.e Cheque counter foil particularly by name, Sl. No. ix i.e Details of account number in which amount credited and Sl. No. x i.e Bank & Branch Name which amount credited from concerned department. Instead, the payment amount in writing should be provided to the appellant. The Respondent PIO was directed to furnish the information by 25th May, 2025 without fail."

Hence, the case is disposed of with liberty to the Appellant to prefer second appeal to the State Information Commission as per section 19 (3) of the RTI Act.

However, the appellant having failed yet again to obtain the information from the PIO, preferred 2nd appeal before this Commission under Section 19 (3) of the RTI Act, 2005 vide Memo of appeal dt. 05.05.2025.

This appeal is, accordingly, listed today on 28.11.2025 wherein both the appellant Shri Bamag Pacho and the PIO, EE, Sangram PWD Division are absent.

It is, however, pertinent to note that the PIO, the EE (Sangram Division), vide his letter dt. 16.10.2025, has informed that consequent upon bifurcation of Koloriang Division from the Sangram Division and pursuant to SE's order dt. 24.09.2025, the handing over and taking over of the charge of the Koloriang Division has been done on 14.10.2025 and that consequently for the pending RTI cases till 14.10.2025 in respect of the Koloriang Division, the EE (Koloriang Division) be summoned.

In the premises as above, this Commission deems it appropriate to summon the PIOS of both the Sangram Division and Koloriang Division in the next date to hear them and decide as to whose Division shall provide the requested information.

NOW THEREFORE, you are hereby summoned to appear in person or online in the Hon'ble Court of Shri Sangyal Tsing Bappu, **SIC on the 21st January, 2026 (Wednesday) at 10.30** to answer the claims, and you are directed to produce on that day all the documents upon which you intend to rely in support of your claims/defense.

Take notice that, in default of your appearance, on the day above- mentioned, the matter will be heard and determined in your absence.
