The 6th hearing was held on 4th May, 2026 related to the APIC No-357/A/2025 (Appeal). PIO-cum-Director, Elementary Education, Itanagar present in person but the Appellant Shri Taram Kenji found absent without any intimation to the Commission.

As per the last order Dy. Director of School Education of 8 (eight) districts (1) Papum Pare, (2) Itanagar Capital Region, (3) Lower Dibang Valley (4) Lohit, (5) Tirap, (6) East Siang (7) Upper Subansiri and (8) Lower Siang have already submitted the sought information through the Director of Elementary Education. The Appellant was directed to collect the information from the PIO and intimate to the Commission. The appellant has submitted a letter stating that the documents are not furnished as per his form 'A' application.

The PIO has stated today that all the information are with the concerned DDSEs and had been sending regular intimation letter to them to furnish the documents. It is seen that the concerned DDSEs of the District are not cooperating with the PIO-cum-Director, Elementary Education. Last chance was given to DDSEs to furnish the information and it was already cautioned in the last order that concerned DDSEs will be made as PIO as per Section 19(8) (a)(ii) under RTI Act.

The Director Elementary Education is directed to appoint all the DDSEs of the concerned Districts to be as PIOs for proper adjudication of the appeal case Under Section 19(8)(a)(ii) of RTI Act, 2005.

All the DDSEs of the concerned District are directed to be present in the next date of hearing and also directed to furnish all the information to appellant on or before next date of hearing.

The Commission fixed next date on 27/07/2026 at 1030 hours.
