SUMMON

WHEREAS, in connection with the **APIC-No. 901/2025**, your personal appearance is required before the Commission on **21st July, 2026 at 02:30 PM**. The 1st hearing held on 7th May 2026. The Appellant Shri Lokam Namdu found absent with a letter of absence citing health issue and not able to attend the hearing and so to re-schedule today's hearing to another date.

The PIO-cum Project Director (DRDA) Koloriang, Govt of Arunachal Pradesh, is also absent without reporting the reason for his absence to the Commission.

Due to absence of both the parties, the Commission could not proceed on with the hearing of the appeal

Under the above circumstances the Commission here by pass the below orders;

- i) To **issue warning summons** to the PIO to appear in person or through online mode before the Commission in the next date of hearing. **Failing which necessary action shall be initiated against the PIO as per RTI Act 2005.**
- ii) To **issue summon** to the Appellant to appear in person or through online mode before the Commission in the next date of hearing. **Failing which this appeal shall be heard and determined ex-parte.**
