ORDER

This is an appeal under Section 19(3) of RTI Act, 2005 filed by Shri Nyami Yorpen, Village- Yoji-Yora, Aalo, Po/Ps-Aalo, West Siang District, Aruachal Pradesh, for non-furnishing of information by the PIO-cum-EE (PWD), Govt. of A.P., O/o Public Works Department, Aalo Division, West Siang District, Aruachal Pradesh as sought by the Appellant under section 6(1) of RTI Act, 2005 vide Form-A Dated 24/05/2023 regarding SIDF, BE AND RE (2021, 2022, 2023).

The 1st hearing is held today on 30th January, 2024 as scheduled. Shri Dugjum Lona, the PIO-cum-EE (PWD), Govt. of A.P., O/o Public Works Department, Aalo Division, West Siang District, Aruachal Pradesh is present. The Appellant Shri Nyami Yorpen is absent. The PIO brought a bunch of documents claiming to be the information sought by the Appellant to be furnished. But, could not do so as the appellant is absent.

The appellant is directed to visit the office of the PIO within twenty days from the date of this order and collect information free of cost. If any information are not furnished the Appellant is directed to make a list and submit to the PIO. The PIO is directed to furnish correct, complete and authenticated information to the Appellant. If any information is not available with the PIO, the PIO is directed to give justifiable reason in writing to the Appellant with intimation to the commission.

Both the parties are directed to appear before the Commission's court on the next date of hearing without fail. If the SPIO is found absent the Commission may initiate penal action as per provision under section 20(1) of the RTI Act-2005 and in case Appellant is absent the case shall be disposed of without any further notice, presuming that the Appellant is satisfied with the information so furnished.

The next date of hearing is fixed on 23rd April, 2024 (Tuesday) at 1030 hrs.

Therefore, the PIO-cum-EE (PWD), Govt. of A.P., O/o Public Works Department, Aalo Division, West Siang District, Aruachal Pradesh is hereby summoned to appear before this Court in person on the scheduled date and time without fail.
