**SUMMON.**

The 3<sup>rd</sup> hearing held on **17<sup>th</sup> April, 2025** related to the **APIC No-239/2024**. The Appellant Shri Pisa Tapam absent. The PIO is represented by Shri Hibu Gyadi (Junior Engineer) Hydro Power Development, Corporate Head Office, HPDCAPL, Itanagar, during the hearing before the Commission.

**Heard the representative of the PIO:**

The representative of the PIO stated before the Commission that all the information(s) pertaining to Serial No. 16 of the Form-A application of the Appellant have been provided as per rules of RTI, Act, 2005 on 7<sup>th</sup> February' 2025 to the Appellant by hand.

After hearing the representative of the PIO: The Commission observes;

That the information(s) C/o Taksang Chu SHP-(2 x 1.7) MW in Tawang District under MNRE, all the information(s) have been furnished to the Appellant and therefore, the information(s) sought by the Appellant in his Serial No. 16 will not be heard anymore as all information(s) pertaining to Serial No. 16 have been provided to the Appellant and the hearing for rest of the information(s) kept by the concern PIO will continue.

After Hearing the representative of the PIO, and after consideration of the circumstances and pursuant to the relevant provisions of the RTI, Act, 2005, the Commission hereby orders as follows;

- (i) **Summons** be issued to the Appellant to attend the next date fixed for hearing in person or through online mode, failing which this instant appeal will be heard ex-parte.
- (ii) **Summons** be issued to the PIO-cum-EE, (Hydro Power Division LHOU-I) Tawang, to be present in person or through online mode in the next date of hearing, failing which necessary action will be initiated against the PIO as per the provisions of RTI, Act, 2005.
- (iii) **Summons** be issued to the PIO-cum-EE, (Hydro Power Division LHOU-II) Tawang, to be present in person or through online mode in the next date of hearing, failing which necessary action will be initiated against the PIO as per the provisions of RTI, Act, 2005.
- (iv) Next date of hearing has been intimated to the representative of the PIO so, no formal notice need to be issued to the PIO.

**The next date of hearing be fixed on 3<sup>rd</sup> July, 2025' at 10:30 AM (Morning)**
