The 2<sup>nd</sup> hearing was held on 24<sup>th</sup> November, 2025 related to the APICs No-192/2025, 193/2025 & 194/2025(Appeal). The PIO-cum-EE (PWD), Dirang Division attended the hearing through VC but the Appellant Shri Mamu Sono found absent, however, he intimated to the Commission stating that he is unable to be present today because of urgent work.
