ITANAGAR. An Appeal Case U/S 19(3) of RTI Act, 2005 Case No. APIC-71/2025. (Summon to appear in person) (Or.5, R.3 of CPC)

SUMMONS

This is an appeal under Section 19(3) of RTI Act, 2005 received from Shri Tamchi Gungte for non-furnishing of below mentioned information by the PIO, o/o the Executive Engineer, (PWD), Mariyang Division, District : Upper Siang, Govt. of Arunachal Pradesh as sought for by him under section 6(1) (Form-A) of RTI Act, 2005 vide his application dated 14.10.2024.

A) Particular of information: o/o "Construction of Road from Mindi Yorbe to Govt. Model College, Geku in Upper Siang District" during the financial year 2022-23.

B) Details of information required:

- 1. Certified Sanction Order copy;
- 2. Certified PRC (Permanent Residence Certificate) submitted by tender Participant issued by the Competent Authority regarding domicile status with the Districts ass per Rule 4 (ii)(b) of the Arunachal Pradesh District Based Entrepreneurs and Professionals (Incentive, Development and promotion) Rule, 2015;
- 3. Certified LOC copy;
- 4. Certified copy of utilization certificate;
- 5. Certified copy of Notice Inviting Tender (NIT);
- 6. Certified copy of Progress report of the projects in physical and Financial section till date;
- 7. Certified copy of copy of Completion certificate of the project;
- 8. Certified copy of newspaper in which NIT was published (At least 3 news paper name (one national & 2 Local) along with date of publication of news paper, as per government approved order;
- 9. Certified design and scope of work in the projects;
- 10. Certified copy of work specification of the projects;
- 11. Certified Copy of documents submitted by tender participant for Technical Bid;
- 12. Name of Firms who won the Tender Work;
- 13. Name of Officers and their designation at the time of monitoring the work;
- 14. Certified copy of Contractor Registration, Pass work completion, Contractor enlistment update reports, of tender participant and winning Firm;

- 15. Certified copy of EMD and Security money deposited by all the tender participant.
- 16. Certified Integrity Pact submitted by the tender participant;
- 17. Certified copy of an Affidavit copy sworn before a competent Magistrate by the Contractor, to the effect that he does not have two or more incomplete ongoing commitments (project / contract to execute) at the time of bidding by the tender participant and winning firm. (as per rule SPWD/W-66/2012 Dtd. 01.08.2018);
- 18. Certified documents submitted by tender participant and winning firm, i.e. copy of completed three similar work each of value not less than 40% of the estimate cost or completed two similar work each of value not less then 60% of the estimated cost or completed one similar work of value not less than 80% of the estimated cost in the last 5 years ending last day of the month previous to the one in which the tenders are invited;
- 19. Certified copy of Acceptance letter for Tender Work by the Executing Agency to the tender winning farm;
- 20. Certified copy of Work Order given to the Contractor by the Executing Department;
- 21. Agreement copy made between the Contractor and the Executive Agency for the projects mentioned above;
- 22. Photograph of worksite (Glossy paper) before starting of work and photograph (Glossy paper) after completion of work;
- 23. Geo Coordinate information for the work mentioned above;
- 24. Certified payment details of the project till date;
- 25. Certified Solvency certificate by the Bankers, submitted by all the tender participant;
- 26. Certified credit facility from Bankers (10% of the tender value) submitted by the tender participants;
- 27. Certified affidavit to invest cash up to (25 % of tender value) submitted by the tender participant;

Records in the appeal reveal that the appellant had requested the PIO for the aforementioned information but failed to obtain the same within the statutory period of one moth which prompted him to file appeal before the First Appellate Authority (FAA), the CE (PWD), Central Zone-B, Pasighat under section 19(1) of the RTI Act vide his Memo of Appeal dt.24.11.25. But having failed yet again to obtain the information, he preferred his second appeal before this Commission under section 19(3) of the RTI Act vide his Appeal Memo dt.15.01.2025. Records also reveal that the FAA had attempted to conduct the hearing of the appeal on 16.01.2025 by issuing summon dt.13.12.2024 but there is no further records as to the actual hearing of the appeal and the order passed, if any, by the FAA. Be that as it may, the 2nd appeal having been preferred by the appellant, has been registered in this Commission and listed for hearing today on 23.04.2025.

In the hearing today the appellant, Shri Tamchi Gungte is present in person but the PIO nor any of his representatives was present.

Heard the appellant who submitted that he could not attend the hearing called by the FAA on 16.01.2025 at Pasighat as he was attending a hearing in this Commission on that day.

Since the hearing could not be conducted due to absence of the PIO, this appeal is again listed on 21.05.2025.

You are hereby summoned to appear in person or online in the Hon'ble Court of Shri Sangyal Tsering Bappu, SIC in person on the 21st May, 2025 (Wednesday) at 10.30 am to answer the claims, and you are directed to produce on that day all the documents upon which you intend to rely in support of your claims/defense.

NOW THEREFORE, take notice that, in default of your appearance, on the day above- mentioned, the matter will be heard and determined in your absence.
