Hearing Notice.

The 2nd hearing was held on **2nd February, 2024** related to the **APIC No-1066/2023 (Appeal)**. The PIO present along with third parties during the hearing. But the appellant found absent.

The PIO has intimated to the Commission that all the information as sought by the appellant in his form 'A' application are kept ready to furnish to the appellant except **Sl. No. ix**. He also intimated to the commission during the hearing that he asked the appellant to collect the information from the office of the PIO, Chandranagar, Itanagar. But, the appellant intimated to the PIO that presently he is out of station and assured to collect the information after returning back at Itanagar. The PIO also intimated to the Commission that the information as sought by the appellant are very bulky and voluminous, so, he requested to the Commission to direct the appellant to collect the information from the PIO's Office, Chandranagar, Itanagar. On the request of the PIO, the Commission directed the appellant to collect the information from the office of the PIO.

The PIO and the learned counsel Advocate explained the reason of why the third party denied to furnish, as the information asked in the Serial No. – ix are purely personal and it falls under Section-8 Sub- section -1(J).

After going through all the available documents/records and also hearing from the parties, the Commission directed the appellant to collect the information from the office of the PIO immediately after returning back from the outstation except the serial No.-ix. The Commission also directed the appellant to intimate his satisfaction or dissatisfaction to the Commission on or before next date of hearing. The information which are sought in the Serial No.-ix are found personal document and no larger public interest is seen in this matter. So, the appellant is directed to collect the rest information as the PIO kept ready in his Office at Chandranagar, Itanagar. The Commission also directed the PIO to present in person before the Commission in the next date of hearing.

The Commission fixed the next date of hearing on **13th March, 2024 at 2 PM.**
