SUMMON-CUM-ORDER.

The 7th hearing was held on 27th July, 2026 related to the **APIC No-357/2024 (Appeal)**. Appellants Shri Taram Kenji found absent without any intimation to the Commission. PIO-cum-DDSEs- Lohit, Leparada, Longding, Kra-Daddi, Kamle and Lower Siang present through VC and the DDSEs- Pasighat, Changlang, Dibang Valley, East Kameng, West Kameng and Namsai present in person.

1. As per the order dated 04/05/2026, a written reply has received from the DDSE, Upper Siang District stating that information sought is not available as no appointment of TGT/PRT is done from the district.
2. Written reply from DDSE, Lohit has been received and today he is present through VC and stated that information sought by the appellant has already been furnished to the Director of Elementary Education on 28/10/2025. Abstract copy of same is received by this Commission on 06/06/2026
3. Written reply from DDSE, Tirap has been received stating that no TGT/PRT appointment has been made in Tirap District as per the Form 'A' application.

Information sought by the appellant has already been furnished to the Director of Elementary Education on 28/10/2025 abstract copy of same is received by this Commission on 06/06/2026.

4. PIO-cum-DDSE, Lepara District present through VC and stated that information sought has already been furnished to appellant through postal address on 20/07/2026 and submitted abstract copy of the same to this Commission.
5. PIO-cum-DDSE, Longding present through VC and stated that reply has already been made to the Nodal Officer-cum-APIO, Directorate of Elementary Education on 23/03/2026 and copy of the same is submitted to this Commission.
6. Written reply has been received from the PIO-cum-DDSE, Kra-Daddi stating that as per the Form 'A' application, there is only 2 (two) TGT are found in the list but both of them are working under Samagra Shiksha (ISSE) in Palin. DDSE, Kra-Daddi present through VC.
7. PIO-cum-DDSE, Kamle present through VC and stated the he has received only W.T. Message through Deputy Commissioner, Kamle District. Therefore, he could not provide any document to the appellant as per his form 'A' application. Form 'A' application along with order copy be sent to the concerned DDSE compliance of the Commission's order.
8. PIO-cum-DDSE, Lower Siang attended through VC and stated that he has already provided all the information to the appellant.
9. PIO-cum-DDSE, Pasighat is represented by Shri Ralbom Moyong, APIO and stated that information sought has been furnished 3 times to the appellant through his postal address but the documents returned unserved from post office due to incorrect address. Again he furnished same to the appellant through his postal address on 23/07/2026 abstract copy of the same is submitted to this Commission.

10. PIO-cum-DDSE, Changlang present in person and brought all the sought documents and the abstract copy of the same is submitted to the Commission today. Appellant is directed to collect the sought information from the PIO as it is stated that the postal address given by the appellant is in correct and all the letters sent to the appellant is returned un-served due to in correct address.
11. PIO-cum-DDSE, Dibang Valley present in person and stated that all the information has already been furnished to the Director of Elementary Education, Govt. of Arunachal Pradesh, Itanagar on 16/03/2026 and abstract copy of the same is submitted to this Commission today.
12. PIO-cum-DDSE, East Kameng is represented by Shri Sunil Kr, Choubey, Resources Person (ISSE) and stated that he has brought the sought information but could not headed over to the appellant due to absence of the appellant. Appellant is directed to collect the information from the PIO. Abstract copy of the same is submitted to this Commission today. Information sought for Sl. No 36, 38 & 78 are contractual under ISSE, but the sought information as per form 'A' is for regular TGT/PRT teachers.
13. PIO-cum-DDSE, West Kameng present in person and brought the sought information submitted it to the Director of Elementary Education, Govt. of Arunachal Pradesh and abstract copy of the same is submitted to this Commission. Appellant is directed to collect the information from the Office of the Directorate of Elementary Education, Itanagar.
14. PIO-cum-DDSE, Namsai is represented by Shri Gyamar Tajik, BEO and stated that information sought has already been furnished to the Secondary/Elementary Education on 12/06/2026 and abstract copy of the same is submitted to this Commission today.

Director of Elementary Education is directed to remind all the remaining/rest of the DDSEs to provide the sought information in continuation to earlier order dated 04/05/2026.

Appellant is directed to collect all the submitted information from the Directorate of Elementary Education, and intimate to the Commission on or before next of the hearing. If no intimation is made, the Commission will presume that the appellant has been provided all the information and is satisfied.

Today the appellant is found absent without any intimation for the second consecutive times. If appellant is found absent in the next hearing, the Commission will presume that the appellant is no more interested to pursue this appeal case and accordingly, the appeal case will be decided in his absence and disposed of.

Commission adjourned the hearing and fixed next date of hearing on 09/09/2026 at 2 PM.
