**SUMMON**

WHEREAS, in connection with the APIC-No. 592/2025, your personal appearance is required before the Commission on **25<sup>th</sup> June, 2026 at 10:30 AM**. The 1<sup>st</sup> **hearing held on 9<sup>th</sup> April' 2026**. The Appellant Shri Chungma Sangbia, present during the hearing and the PIO-cum Director Social Justice Empowerment Tribal Affairs (SJETA) is found absent during the hearing without intimating to the Commission the reason for his inability to attend the hearing, which is unbecoming on the part of the PIO, who has to be reminded that the PIO besides, public duties also has to attend Court hearing when an appeal is preferred against him as per the provisions of the RTI Act 2005, which is a statutory duty binding upon the PIO

**Heard the Appellant.**

The Appellant stated before the Court of the Commission that the PIO has not furnished any of the information(s) as sought by him in his form 'A' application till date.

Due to absence of the PIO, the Commission could not proceed the hearing of the appeal.

- i) To send **summons** to the PIO-cum Director SJETA Itanagar Govt. of A.P, to provide all the information to the Appellant on or before the next date of hearing without fail and to attend the next date of hearing without fail to answer the accusation of the Appellant. **Failing which, appropriate action shall be initiated against the PIO as per the provisions of the RTI Act, 2005.**
- ii) The Appellant to appear in person or through online mode before the Commission, in the next date of hearing. **Failing which this appeal shall be heard and determined ex-parte.**
