SUMMON.

WHEREAS, in connection with the APIC-No. 313/2025, your personal appearance is required before the Commission on **22nd January, 2026 at 10:30 AM**. The 1st hearing held on **25th September, 2025**. The Appellants Shri Riya, Bengia Tahar and Lokam Namdu are absent without informing the Commission about their absence, whereas, the notice for today's hearing was already sent to the Appellants on **12.06.2025**.

The PIO-cum-Executive Engineer, PWD, Palin Division, Kra-Daadi District, Govt. of Arunachal Pradesh is represented by Shri Ige Godak Lower Division Clerk (LDC), PWD, Palin Division during the hearing before the Commission.

Heard the representative of the PIO;

The representative of the PIO submitted that a letter was written and sent by the PIO on 14.02.2025 to one of the Appellant Shri Riya Taram, stating that the Form-A application submitted by the Appellants are vague and not specific, it is just beating around the bush, and therefore, the name of the work for which the information(s) are required by the Appellants be mentioned specifically. Taking serious note of the absence of the Appellants the Commission hereby orders;

- i) To send summons to the Appellants to be present in the next date of the hearing without fail, failing which this instant appeal will be heard and determined ex-parte.
- ii) The PIO-cum-EE, PWD, Palin Division, Govt. of Arunachal Pradesh to be present in the next date of hearing without fail, failing which necessary action as per the provisions of RTI, Act, 2005 will be initiated against the PIO.
- iii) Notice need not be issued to the PIO as his representative is present during the hearing before the Commission.

The Commission hereby orders;

The next date of hearing be fixed on 22nd January' 2026' at 10:30 AM (Morning).
