SUMMON

This is an appeal under Section 19(3) of RTI Act, 2005 received from Shri Bengia Papo for non-furnishing of 15(fifteen) point information regarding CAMPA fund from 2019-25 in Koloriang District by the PIO, o/o the DFO, Koloriang, Kurung Kumey District (A.P) as sought for by him under section 6(1) (Form-A) of RTI Act, 2005 vide his application dated 25.06.202.

This appeal was listed for 3 (three) times on 11.02.2026, 11.03.2026 and 10.04.26 but the PIO did not appear on any of the hearings nor deputed any representative nor did the PIO furnish the requested information and/or the affidavit which amounted to blatant disregard to this Commission's direction contained in orders dt.11.02.26 & 11.03.26 and the RTI regime constraining this Commission to issue show cause notice dt.13.04.26 to him to appear in person on **29.04.26 (Wednesday) at 11.30 am** with his replies to the said notice and explain as to why penalty of Rs.25,000.00 (Rupees twenty five thousand) as prescribed under section 20(1) of the RTI Act, 2005 should not be imposed on him.

This Commission is, however, in receipt of letter dt.15.04.26 from the PIO, Shri Doge Basar, DFO (as reproduced below) stating that he could not appear in the hearing on 10.04.26 due to pre-occupation in some urgent official work for which he had also intimated this Commission vide his letter dt. 28.03.26. He also requested for postponement of the hearing of his explanation to the show cause notice fixed on 29th April, 2026 to last part of May, 2026 or early part of June, 2026 as he shall be out of State.

With reference to Memo No. under reference, I would like to draw your kind attention that I have appealed the commission to adjourn the hearing fixed on 10th April '2026 vide this office letter No. cited above. I have personally handed over my appeal letter to the PA/PS of Shri S.
