ORDER

This is an appeal under Section 19(3) of RTI Act, 2005 filed by Chau Sumanta Khen, village-Jenglai, P.o.-Piyong, P.S-Namsai, Namsai District, Aruachal Pradesh, for non-furnishing of information by the PIO-cum-EE (PWD), Govt. of A.P., O/o Public Works Department, Namsai Division, Namsai District, Aruachal Pradesh as sought by the Appellant under section 6(1) of RTI Act, 2005 vide Form-A Dated 19/05/2023 regarding Construction of Link Road from 5.00km point of Chowkham –Wakro road to Tiyang River via coconut garden.

The 1st hearing is held today on 30th January, 2024 as scheduled. Shri S.S.Singh, the PIO-cum-EE (PWD), Govt. of A.P., O/o Public Works Department, Namsai Division, Namsai District, Aruachal Pradesh is present. The Appellant Shri Sumanta Khen is absent. The PIO has submitted that he has furnished all the relevant information to the Appellant on 16th June,2023 and second time on 26th July, 2023. It seems that the appellant is satisfied with the information furnished by the PIO. However, for the end of Principle of natural justice, and fair opportunity, Commission decides to hear from the appellant on 23rd April, 2024.

Both the parties are directed to appear before the Commission's court on the next date of hearing without fail. If the PIO is found absent the Commission may initiate penal action as per provision under section 20(1) of the RTI Act-2005 and in case Appellant is found absent the case shall be disposed of without any further notice, presuming that the Appellant is satisfied with the information so furnished.

The next date of hearing is fixed on 23rd April, 2024 (Tuesday) at 1030 hrs.

Therefore, the PIO-cum-EE (PWD), Govt. of A.P., O/o Public Works Department, Namsai Division, Namsai District, Arunachal Pradesh is hereby summoned to appear before this Court in person on the scheduled date and time without fail.
