**ORDER**

Fact of the case is that this is an appeal under Section 19(3) of RTI Act, 2005 filed by Shri G.F. Rimo, Papu-II, Near Govt. Pry. School, Papu Village, Naharlagun, Papum Pare District, Arunachal Pradesh, for non-furnishing of information by the PIO-cum-ADC, Thrizino, West Kameng District, Arunachal Pradesh Pradesh as sought by the Appellant under section 6(1) of RTI Act, 2005 vide Form-A Dated 11/07/2023 regarding compensation of power grid cooperation of India PVT. LTD (Construction of 132 KV transmission line, Nichipu to Palizi and Palizi to Trizino.

**The 1<sup>st</sup> hearing is held today on 5<sup>th</sup> March, 2024 as scheduled.** The PIO-cum-ADC, Thrizino, West Kameng District, Arunachal Pradesh Pradesh is represented by Shri Koj Tado, the APIO-cum-Co, Jamiri. The appellant shri F.F. Rimo is present. The APIO has submitted that the information sought by the information seeker is vague and not specific, so he could not take action in time. The APIO has also submitted that there is no such scheme as mentioned in the Form-A Dated 11/07/2023 as submitted by the appellant. Further stated that there is a scheme, construction of 132 KV line from Khupi to Seppa.

After argument made by both the parties and submission it is found that the information sought by appellant in Form-A is not clear. So, he was made clear by the APIO and after the clarification the appellant has agreed to seek information of the 132 KV line transmissions from Khupi to Seppa. The PIO is directed to furnish information which comes under his jurisdiction within 28(twenty eight) days from the date of issue of this order. The PIO has agreed to furnish the information as per direction of the Commission. The appellant is directed to keep in touch with the PIO and collect information from the office of the PIO within twenty eight days. On compliance, both the parties are directed to intimate the commission of their action taken. The court is adjourned for the next date of hearing.

Both the parties are directed to appear before the Commission's court on the next date of hearing without fail. If the SPIO is found absent the Commission may initiate penal action as per provision under section 20(1) of the RTI Act-2005 and in case Appellant is found absent the case shall be disposed of without any further notice, presuming that the Appellant is satisfied with the information so furnished.

**The next date of hearing is fixed on 4<sup>th</sup> April, 2024 (Tuesday) at 1400 hrs.**

**Therefore,** the PIO-cum-ADC, Thrizino, West Kameng District, Arunachal Pradesh Pradesh is hereby summoned to appear before this Court in person on the scheduled date and time without fail.
