SUMMON.

WHEREAS, in connection with the **APIC-No. 187/2025**, your personal appearance is required before the Commission on **02nd April, 2026 at 10:30 AM**. The 2nd hearing of this appeal held on **27 November 2025**. The Appellant Shri Mamu Sono absent without intimating the Commission the reason for his inability to attend the hearing, despite being notified of the date for 2nd hearing which is on today.

The PIO –cum EE (PWD) Dirang Division West Kameng District, present during the hearing in through online mode.

Heard the PIO.

The PIO stated that the information as sought by the Appellant are ready at his office and the Appellant was also notified through a letter sent to the Appellant on dated **29th October'2025**. But the Appellant till now, has not responded the letter as well as, has not collected the information from the office of the PIO.

After hearing the PIO the Commission hereby observes;

- i) The Appellant Shri Mamu Sono was present during the 1st hearing which was held on **21/08/2025** and on which day the next date for hearing this appeal was pronounced in the court before him.
- ii) In the absence of the Appellant the statement of the PIO could not be ascertained from the Appellan whether he has received the letter from the PIO or not, till now.
- iii) Therefore, a next date of hearing be fixed giving a fair chance to the Appellant for being heard and present.

Under the above stated facts and circumstance, the **Commission hereby orders;**

- i) To **issue summons** to the Appellant to be present in the next date of hearing without fail, **failing which this appeal will be heard and determined ex-parte.**
- ii) PIO to be present in the next date of hearing without fail, **failing which necessary action shall be initiated against the PIO as per the provisions of RTI Act 2005.**
- iii) The next date of hearing be intimated to the Appellant and no formal notice required to be issued to the PIO, as he is present in the hearing.

The Commission orders;

The next date of hearing be fixed on 2nd April' 2026 at 10:30 AM (Morning)
