ORDER/SUMMON

This is an appeal under Section 19(3) of RTI Act, 2005 received from Shri Nabam Tadop for non-furnishing of below mentioned information by the PIO, o/o the EE (RWD), Yupia Division, Itanagar, Govt. of Arunachal Pradesh as sought for by him under section 6(1) (Form-A) of RTI Act, 2005 vide his application dated 24.07.2025.

(c) Particulars of information: - Regarding how many times fund allocated for construction of bridges these 3 rivers are (i) Hollongi (ii) Chanmara (iii) Chessa, Govt. of A.P.

(d) Details of Information:

1. Please furnish/provide certified copy how many times fund received /allocated, along with mentioned name of the scheme from Government of Arunachal Pradesh/India for construction of 3(three) numbers of bridges against these rivers are (i) Hollongi river(ii) chanmara river(iii)chessa river.
2. Please furnish/provide certified copy of the DPR/Sanctioned order copy/Administrative Approval copy.
3. Please furnish/provide certified copy of the successful bidder bid documents (i) Contractors registration/enlistment copy (il) Trading license, (ii)ST Certificate (iv) PRC Certificate (v)GST registration with latest return filling copy Contractor (vi) Pan card (Vii) Voter I.D (viii) Aadhar card (ix) ITR return filling copy (x) EPF registration with Latest return filling copy(xi) Non litigation affidavit copy.(xii) Affidavit not engage more than three work.
4. Please furnish/provide certified copy of the official order inviting the firms/contractors for attending/participation of the tender process/called e-tender and also furnish copy of local/news paper published aforesaid NIT.
5. Please furnish/provide certified copy of how many firms were qualified for technical bid and also how many firms has been recommended for price bid to set screening or scrutiny along with showing rate quoted by various firms.
6. Please furnish/provide certified copy of the Board proceeding for selection/acceptance bidders in connection with aforesaid contract work and other letter of correspondences.
7. Please furnish/provide certified copy of the bill of quantity (BOQ) along with comparative statement of L,1&L,2 bidders.
8. Please furnish/provide certified copy of the Board proceeding for selection/acceptance bidders in connection with aforesaid contract work and other letter of correspondences.

9. Please furnish/provide certified copy of the work agreement made between contractors/firms and Rural Work Department.
10. Please furnish/provide certified copy of the work completion report copy along with photograph submitted by concern competent authority against aforementioned bridges details.
11. Please furnish/provide certified copy of the how many amount has been made payment so far against different heads of the works completed details.
12. Please furnish/provide certified true copy of counter foil/challan/cheque issue and cheque number /PMFS Generated print payment Advise in respect of above-mentioned works/firm.
13. Please furnish/provide certified copy of the monitoring team report copy submitted against cited project along with copy of CD/Videography which was done by the monitoring team against the various components of work during the course of made to the contractor/agency.
14. Furnished the utilization certificate.
15. Furnish the copy of 1" Geo tag & 2" Geo tag photo copy.
16. Furnish the status report copy of the aforementioned bridges and also whether the payment has been made completed or not? & furnish the details.

Brief facts emerging from the appeal:

Records emerging from the appeal disclose that the appellant, Shri Nabam Tadap had requested the PIO for the aforementioned information/documents but failed to obtain the same which prompted him to appeal before the Superintending Engineer (RWD), Itanagar Circle, Govt. of A.P, Itanagar, the First Appellate Authority (FAA) under Section 19 (1) of the RTI Act, 2005 vide his Memo of Appeal dt. 28.08.2025. However, the appellant failed yet again to obtain the information and therefore, he preferred 2nd appeal before this Commission under section 19 (3) of the RTI Act. 2005 vide his Memo of appeal dt. 03.10.2025.

Hearing and decision:

This appeal was, accordingly, heard on 11.02.2026 wherein the appellant, Shri Nabam Tadap and the PIO, o/o the EE(RWD), Yupia Division, Er. Shri Takam Majeng were present in person.

This Commission upon hearing the parties and noticing that the requested information/documents by the appellant vide Sl.No.16 i.e the status report of the bridges and the payment thereto are not exempted under any of the exemption clauses of section 8(1) of the RTI Act, 2005, directed the PIO, vide order dt.11.02.2026, to furnish the said left out information to the appellant as per his query within 2(two) weeks from the date of receipt of the said order which was delivered to the PIO on 13.02.26 through Whatsapp.

The Commission, however, received letter dated 27th Feb. 2026 (extracted below) from the appellant, Shri Nabam Tadap complaining that the PIO has not complied with the order of this Commission and hence, requested for hearing the appeal again.

"Hon'ble sir,

I have honor to inform you that sir, I haven't received the documents or reply from concerned PIO despite passing two weeks above and also I visited twice in the PIO office more over its seems dishonor to court judgment order which was decree

order passed by Hon'ble court dated on 11-02-2026 to furnish within two weeks RTI Form 'A' Serial No-16 So, may I request you kindly re-fixed for hearing another date so that I could obtaining aforementioned RTI reply/documents from concerned PIO.

Therefore, I highly request you sir, kindly considered above the cited subject and kind necessary action please.

In the premises as above the PIO, o/o the EE, RWD, Yupia Division is hereby directed to furnish the left out information i.e Sl.No.16(status report of the bridges and the payment thereto) at right earnest. This Commission, however, makes it clear that as required by law under section -7(8)(i) of the RTI Act when an information is denied to the applicant, the reason thereof has to be communicated to the applicant to his satisfaction. And as mandated by section-18(3)(c) and under rule- 5(vi) of the AP Information Commission (Appeal Procedure) Rules, 2005, the submission/reply of the PIO has to be declared/supported by way of an affidavit.

The PIO is, therefore, directed to furnish the left out information or/and the affidavit to the appellant in right earnest and report the compliance therewith on 10th April, 2026, the next date of hearing.

Take notice that, in default of your appearance, on the day above- mentioned, the matter will be heard and determined in your absence.
