

## ARUNACHAL PRADESH INFORMATION COMMISSION, APIC

ITANAGAR An Appeal Case U/S 19(3) of RTI Act, 2005. Vide Case No. APIC-216/2024

# <u>ORDER</u>

The 5<sup>th</sup> hearing held on <u>3rd April, 2025</u>' related to the <u>APIC No-216/2024</u>. The Appellant and the PIO both are present through online mode, during the hearing before the Commission.

### Heard the Appellant;

The Appellant stated before the Commission that master map of Gumin Nagar, Pasighat, East Siang District, provided by the PIO is a fake one as he had earlier submitted before the Court of this Commission that the PIO also does not have any legible master map and now, how and from where he has provided him a traced out copy, of the same?. If at all a new master map is to be drawn again, there has to be a proper official procedure to draw it and get the approval from the competent authority.

And therefore: the PIO be ordered to provide a master map which is legible and adduced with the official procedures followed to draw and approve a new master map and thereby provide him a copy of the details of correspondence of the approval of the master map of Gumin Nagar area along with the master map.

Further the Appellant submitted that the PIO is yet to provide him the information(s) regarding;

- Concept paper of the District administration, East Siang District to allot land at Gumin Nagar area to the public of Arunachal Pradesh.
- (ii) The copy of the Recommendation letters from the office of the Deputy Commissioner, East Siang District to the Govt. of Arunachal Pradesh for land allotment to private individuals at Gumin Nagar, Pasighat.
- (iii) The copy of the approval letter from the Govt. of Arunachal Pradesh to the Deputy Commissioner, East Siang District regarding the names of the allottees of Gumin Nagar area of Pasighat town.

### Heard the PIO;

The PIO stated before the Commission that the information(s) sought by the Appellant under his Form-A application have already been provided, such as master map, 361 approved land allotment orders and regarding the rest matters discussed; he will provide it to the Appellant on or before the next date of hearing of this Appeal.

## After hearing both parties: the Commission hereby orders;

(i) The PIO to provide copies of a legible master map with the copies of due official procedure followed, if a new master map is to be drawn and approved by the competent authority.

- (ii) Copy of the concept paper for allotment of land at Gumin Nagar, Allotment approval from Director Land Management, Govt. of Arunachal Pradesh, and Recommending letters for allotment of plots at Gumin Nagar from office of the Deputy Commissioner, East Siang District, Govt. of Arunachal
- (iii) Pradesh, to the Appellant on or before the next date of hearing, failing which necessary action shall be initiated against the PIO as per the provisions of RTI, Act, 2005.
- (iv) Notice need not be issued to both the parties as they are present during the hearing before the Commission.

# The next date of hearing be fixed on 19<sup>th</sup> June, 2025' at 10:30 AM (Morning).
