**SUMMON**

**WHEREAS**, in connection with the **APIC-No. 393/2025**, your personal appearances required before the Commission on **19<sup>th</sup> May 2026 at 02:30 PM**. The 1<sup>st</sup> hearing held on **26<sup>th</sup> February 2026**. The Appellant Shri Chow Chali Simit present during the hearing through online mode but the **PIO-cum EE (PHE & WSD)** Namsai Division, District Namsai, is absent during the hearing without intimating to the Commission the reason for his inability to attend the hearing, which is unbecoming on the part of the PIO, who has to be reminded that the PIO besides, public duties also has to attend Court hearing when an appeal is preferred against him as per the provisions of the RTI Act 2005, which is a statutory duty binding upon the PIO.

Due to absence of PIO, the Commission could not proceed the hearing of the appeal.

**The Commission hereby orders;**

- i) To **issue summons** to the PIO to appear in person or through online mode before the Commission in the next date of hearing. **Failing which necessary action shall be initiated against the PIO as per RTI Act 2005.**
- ii) The PIO to provide all the information(s) which are available in the office of the PIO on or before the next date of hearing
- iii) The Appellant to be present in person or through online mode before the Commission in the next date of hearing. **Failing which this appeal shall be heard and determined ex-parte.**
