SUMMON-CUM-ORDER.

The 1st hearing was held on **12th August, 2026** related to the **APIC NO-931/A/2025(Appeal)**. Appellant Shri Nabam Tadap present but PIO-cum-O/o the Deputy Chief Wildlife Warden Itanagar, Wildlife Sanctuary Naharlagun Division absent without any intimation to the Commission.

As per the case record, the FAA had directed to provide all the sought information within 30 days on payment of the paper charges. Initially, the Appellant was asked to pay an amount of Rs 5,000 being the cost of paper and Xerox charges.

Later on, on 19th October, 2025 the Dy. Chief Wildlife Warden Itanagar Wildlife Sanctuary Division has asked the Appellant to pay Rs 2,070 through e-Grass challan for the charges of paper and Xerox.

The Appellant stated that he has already deposited the amount for paper and Xerox charges. However, the information has still not been provided. It is also seen that no record showing that the amount for paper and Xerox charges has been deposited by the Appellant.

Both the parties are directed to be present in next date of hearing.

Commission adjourned the hearing and fixed next date of hearing on **5/10/2026 at 1030 hours**.
