**The 11<sup>th</sup> hearing** was held on 29<sup>th</sup> **September, 2025** related to the **APIC No-1012/2023 (Appeal)**. The appellant Shri Lening Pertin attended the hearing through VC but the PIO-cum-DFO, Pasighat Forest Division found absent.

As per the case record, reply of the Show Cause Notice is received from the PIO-cum-DFO on 29/08/2025 stating the reasons for non-appearance in the Commission. A copy of letter received from DFO, Pasighat dated 04/07/2025 written to the appellant Shri Lening Pertin stating that the documents sought by the appellant is ready and may collect from the Division Office. Another letter addressed to the appellant Shri Lening Pertin regarding the intimation of dates fixed for inspection of documents/files. The inspection dates were fixed from 08/09/2025 (Monday) to 12/09/2025 (Friday) morning 10 AM to 1 PM and afternoon 3 PM to 4.30 PM. The PIO also stated that the Head Assistant-cum-APIO of the DFO Office, Pasighat will facilitate during the inspection.

But today the appellant stated before the Commission that he has not received any such letter for inspection from the office of the PIO. But he states that he has received a letter addressed to him regarding the collection of the documents from the Division Office.

The appellant is directed to collect the information from the office of the DFO, Pasighat as per letter dated 04/07/2025. The PIO-cum-DFO, Pasighat Forest Division is directed to re-fix a suitable date for inspection of the documents/files as the appellant stated before the Commission that he has not received any such date for inspection of the documents. PIO is also directed to be present in person before the Commission in the next date of hearing.

The fixed next date of hearing on 10/12/2025 at 2 PM.
