**SUMMON**

**WHEREAS**, in connection with the **APIC-No. 290/2024**, your personal appearance is required before the Commission on **4<sup>th</sup> December, 2025 at 10:30 AM**. The **3<sup>rd</sup>** hearing held on **26<sup>th</sup> August' 2025** related to the **APIC- No-290/2024**. The Appellants Shri Taram Kenji and Nangram Ganesh are absent without intimating the Commission about their inability to attend the hearing.

The PIO office of the Commissioner, Itanagar Municipal Corporation (IMC), Gohpur, Itanagar, Papumpare District, Govt. of Arunachal Pradesh, found absent consecutively for 03(Three) times without intimating to the Commission the reason for his/her inability to attend the hearing, which is unbecoming on the part of the PIO, who has to be reminded that, the PIO besides public duties, also has to attend Court hearings when an appeal is preferred against him as per the provisions of the **RTI, Act, 2005**, which is a statutory duty binding upon the PIO.

**In the absence of both the parties, the Commission observes;**

- i) During the hearing, on 01.04.2025, the Appellant stated before the Commission that the PIO has not furnished any of the information(s) as sought by him in his Form-A application till date. And has requested the Commission to initiate legal action against the PIO as per the provisions of RTI, Act, 2005.
- ii) Despite warning summons sent to the PIO on 01.04.2025, the PIO has not responded to the order of the Commission, and therefore, it is deemed as contempt of the Court order of this Commission.

**And therefore, the Commission hereby orders;**

- i) To issue bailable warrant of arrest to the PIO of the office of Commissioner, Itanagar Municipal Corporation (IMC), Gohpur, Itanagar, Papumpare District, Govt. of Arunachal Pradesh, directing the officer in-charge of Chimpur Police Station, Papumpare District, to execute and return the bailable warrant of Arrest, and produce the errant PIO on the next date of hearing i.e on **4<sup>th</sup> day of December' 2025' at 10:30 AM, without fail**, before this Court.

- ii) The copy of this bailable warrant of arrest be served to the Superintendent of Police, Papumpare District for compliance.
- iii) The copy of this bailable warrant of arrest be served to the Chief Secretary, Govt. of Arunachal Pradesh, for information.
- iv) Send summons to the Appellants to be present in the next date of hearing without fail, failing which this appeal will be heard and determined ex-parte.

**The Commission hereby orders;**

**The next date of hearing be fixed on 4<sup>th</sup> day of December' 2025 at 10.30 AM, (Morning).**


