ORDER/SUMMONS

This is an appeal under Section 19(3) of RTI Act, 2005 received from Shri Minli Ete for non-furnishing of below mentioned information by the PIO, o/o the E.E (RWD), Aalo, West Siang District (A.P) as sought for by him under section 6(1) (Form-A) of RTI Act, 2005 vide his application dated 19.03.2025:

A) Particular of information: Nehru Road to Darka Road PMGSY.

B) Details of information required:

1. Copy of DPR and TS;
2. Details of the fund received and payment made against the Scheme;
3. Copy of the work order issued to the implementing firm;
4. Copy of the handing and taking over of the road from the PWD;
5. MB Book/ Pending Bill received from PWD and
6. Total amount transfer to account.

C) Period for which information required:

Brief facts emerging from the appeal:

Records emerging from the appeal disclose that the Appellant, Shri Minli Ete had requested the PIO for the aforementioned information / documents but failed to obtain the same which prompted him to appeal before the Chief Engineer (RWD) (PMGSY), Govt. of Arunachal Pradesh, Itanagar as the First Appellate Authority (F.A.A) under Section 19 (1) of the RTI Act vide his Appeal Memo dated 15.05.2025.

Records, however, reveal that the FAA did not adjudicate the appeal as required under section 19(1) of the RTI Act except issuing an instruction vide letter dt.16.06.2025 to the PIO to take necessary steps to furnish the required document to the appellant at earliest possible.

But dissatisfied with the response of the FAA as above and non-receipt of information from the PIO, the appellant filed his 2nd appeal before this Commission under section 19(3) of the RTI Act vide Memo of Appeal dt.04.09.2025.

Hearing and decision :

The appeal is, accordingly, listed for hearing today on 26.11.2025 wherein the appellant, Shri Minli Ete is present in person but the PIO is absent without any intimation.

Heard the appellant who has reiterated his demand for the requested information and pleaded for an appropriate direction to the PIO to furnish the information/documents and also penal action against him for violating the provisions of RTI Act and also for not complying the order of this Commission.

The non-appearance of the PIO without intimation is viewed seriously and if the PIO fails to appear in the next date on 28th January, 2026, this Commission shall be constrained to invoke the penal action under the relevant provisions of the RTI Act, 2005.

The PIO is, thus, directed to furnish the requested documents to the appellant and report compliance thereof on 28.01.2026.

NOW THEREFORE, you are hereby summoned to appear in person or online in the Hon'ble Court of Shri Sangyal Tsering Bappu, **SIC on the 28th January, (Wednesday) at 10.30 am** to answer the claims, and you are directed to produce on that day all the documents upon which you intend to rely in support of your claims/defense.

Take notice that, in default of your appearance, on the day above- mentioned, the matter will be heard and determined in your absence.
