WARNING SUMMON

WHEREAS, in connection with the APIC-No. 257/2025, your personal appearance is required before the Commission on **20th JANUARY, 2026 at 01:30 PM**. The 2nd hearing held on **23rd Sept'2025**. The Appellant Shri Tamchi Gungte, found absent during the hearing and the PIO-cum-EE (PWD) Bomdila West Kameng District, also absent during the hearing without intimating to the Commission the reason for his inability to attend the hearing, which is unbecoming on the part of the PIO, who has to be reminded that the PIO besides, public duties also has to attend Court hearing when an appeal is proffered against him as per the provisions of the RTI Act 2005, which is a statutory duty binding upon the PIO.

In the absence of both the **parties the Commission hereby observes;**

It is to be recorded that in the 1st hearing of this appeal 12/06/2025 the Appellant was present but PIO was absent. In the 1st hearing the Appellant had stated that he has received some of the information(s) but the complete information(s) are yet to be provided to him by the PIO.

In the absence of both the parties the Commission could not proceed the hearing of the appeal and therefore, the Commission hereby orders;

- i) To **send warning summons** to the PIO –cum EE (PWD) Bomdila, West Kameng District Govt. of Arunachal Pradesh, for securing his presence in the next date of hearing, failing which action will be initiated against as per provisions of RTI Act. 2005.
- ii) The Appellant to be present in the next date of hearing, **failing which this appeal will be heard and determined ex-parte.**

The Commission hereby orders,

The next date of hearing be fixed on 20th Jan' 2026' at 1:30 PM (afternoon).
