ORDER

This is an appeal under Section 19(3) of RTI Act, 2005 filed by Shri Tageng Jorang, Mega village, Po/Ps-Payum/Kaying, Siang District, Aruachal Pradesh, for non-furnishing of information by the PIO-cum- DDSE, Govt. of A.P., O/o Deputy Director of School Education, Boleng, Siang District, Aruachal Pradesh as sought by the Appellant under section 6(1) of RTI Act, 2005 vide Form-A Dated 21/03/2023 regarding Staffs/appointments/vacancies and salaries of staffs / stipend for students / Mid-Day-Meal.

The 1st hearing is held today on 30th January, 2024 as scheduled. Smti. O.B. Tatak, the PIO-cum- DDSE, Govt. of A.P., O/o Deputy Director of School Education, Boleng, Siang District, Arunachal Pradesh and the Appellant Shri Tageng Jorang are present. The PIO brought bunch of document claiming to be the information sought for by the Appellant and which was duly received by the appellant. After receiving the information the appellant sought time for verification of the information so furnished. The Commission giving fifteen days time for verification directed the appellant to make a list of information if any left out and intimate to the PIO and to the commission within twenty days from the date of issue of this order, failing which the case shall be disposed of. The PIO is directed to furnish complete, correct and authenticated information to the appellant. If any information are not available the PIO must give justifiable reasons in writing to the appellant and intimate to the Commission within seven days after the receipt of list from the appellant, failing which penal action under RTI Act shall be initiate against the PIO.

Both the parties are directed to appear before the Commission's court on the next date of hearing without fail. If the SPIO is found absent the Commission may initiate penal action as per provision under section 20(1) of the RTI Act-2005 and in case Appellant is found absent the case shall be disposed of without any further notice, presuming that the Appellant is satisfied with the information so furnished.

The next date of hearing is fixed on 23rd April, 2024 (Tuesday) at 1030 hrs.

Therefore, Smti. O.B. Tatak, the PIO-cum- DDSE, Govt. of A.P., O/o Deputy Director of School Education, Boleng, Siang District, Arunachal Pradesh is hereby summoned to appear before this Court in person on the scheduled date and time without fail.
