**WARNING SUMMON**

**WHEREAS**, in connection with the **APIC-No. 204/2024**, your personal appearance is required before the Commission on **16<sup>th</sup> April, 2026 at 10:30 AM**. The 2<sup>nd</sup> hearing held on **13<sup>th</sup> Jan'2026**. The Appellants Shri Bengia Tani, found absent during the hearing without intimating to the Commission the reason for their inability to attend the hearing.

The PIO-cum EE (PWD) Sangram Division, District Kurung Kumey is also absent but a letter from the PIO has been received by the Commission, the letter dated 02/12/2025 stating that he has put penalty of **Rs 25,000/- ( Rupees Twenty five thousand)** only as ordered by the Commission on 15/06/2025.

In the absence of the both parties the Commission hereby observes;

This appeal was disposed of on 5/06/2025 with a clear order for furnishing the information to the Appellants within a month from dated received of the order and the PIO was also ordered to pay penalty of Rs 25,000/- for the violation section 7 (i) of RTI 2005 for which the PIO has deposited penalty amount as ordered by the Commission. This is re-hearing this appeal on the request of the Appellants alleging the PIO that information have not been provided to them despite order from this Commission.

Now therefore, under the above stated facts and circumstance the Commission hereby orders;

- i) To **issue warning summon** to the PIO to appear in person or through online mode before the Commission in the next date of hearing. **Failing which necessary action will be initiated against the PIO as per RTI Act 2005.**
- ii) PIO to provide the complete information as sought by the Appellants without fail, **Failing which necessary action shall be initiated against the PIO as per RTI Act 2005.**
- iii) The Appellants to be present in the next date of hearing in person or through online mode before the Commission without fail. **Failing which this appeal shall be heard and determine ex-parte.**

Due to absence of both the parties, the Commission could not proceed the hearing of the appeal.

**The Commission order;**

**The next date of hearing be fixed on 16<sup>th</sup> April' 2026 at 10:30 AM.**
