ORDER/SUMMONS

This is an appeal under Section 19(3) of RTI Act, 2005 received from Shri Lokam Namdu for non-furnishing of information by the Block Development Officer-cum-PIO CD Block, Sarli & Polosang Kurung Kumey District, A.P as sought for by him under section 6(1) (Form-A) of RTI Act, 2005 vide his application dated 17.05.2023.

Records disclose that the appellant had requested for 33(thirty three) point information on implementation of schemes under SIDF/MLA LAD FUND/ UNTIED FUND under the CD Block Sarli & Polosang Circle from 2019-2020 to 2022-2023 from the BDO, CD Block Sarli and Polosang but he failed to obtain the information which prompted him to file his 1st appeal to the 1st Appellate Authority, the D.C, Kurung Kumey District, Govt. of Arunachal Pradesh, Koloriang under section-19(1) vide his Memo of appeal dt.19.06.2023. But he still could not obtain the sought for information from the PIO. Hence, this Second appeal before the Commission which was filed on 09.08.2023.

This appeal is heard today on 09.04.2025 for the 2nd time, the first hearing being on 25.09.2024 wherein the PIO, Shri John Diru, BDO, Sarli and Polosang attended through video Conferencing and the appellant, Shri Lokam Namdu attended in person.

In today's hearing, the appellant, Shri Lokam Namdu was absent without any communication but the PIO was represented by Shri Cherri Nachung, PTA-cum-EO(RE), o/o the BDO, Sarli and Polosang.

Heard the representative of the PIO who submitted that the o/o the BDO, Sarli and Polosang did not implement any scheme/project under SIDF/MLA LAD FUND/ UNTIED FUND under the CD Block Sarli & Polosang Circle during the period mentioned in the RTI application of the appellant and therefore, the question of furnishing the sought for information does not arise. The representative of the PIO also submitted a written submission dt.26.03.25 in this regard a copy whereof is also endorsed to the appellant.

This Commission, upon hearing the representative of the PIO and on perusal of the written submission, is inclined to endorse the submission of the PIO but at the same time deems it appropriate to direct the o/o the PIO to furnish an affidavit declaring that no schemes/projects were implemented by the o/o the PIO on or before 09.05. 2025 as required under rule 5 (vi) of the A.P Information Commission (Appeal Procedure Rules) 2005.

List the appeal on 09.05.2025. If the appellant fails to appear on the said date, this appeal shall be disposed of and closed as not being pressed for further consideration by this Commission.


