**SUMMON.**

**WHEREAS**, in connection with the **APIC-No. 609/2025**, your personal appearance is required before the Commission on 19th March, 2026 at 10:30 AM. The 1st hearing held on 6th November 2025. The Appellant Shri Tamchi Gungte is absent during the hearing without intimating to the Commission the reason for his inability to attend the hearing. The PIO present during the hearing through online mode.

**Heard the PIO.**

The PIO stated that he has joined as PIO on 23/10/2025 and therefore, he does not have any idea about this application. However, on checking the records the previous PIO on **16/6/2025** had written a letter to the Appellant to collect the information(s) from the office of the PIO but the Appellant has failed to collect the information(s) till today.

Furthermore, the PIO stated that the information as sought by the Appellant are ready in his office and Appellant may come any time during office working days and collect the information(s).

**After hearing the PIO the Commission hereby observes;**

- i) When an Appellant file application for information he /she also has the responsibility to collect the information from the office of the PIO.
- ii) The reluctant nature of Appellant to collect the information despite the information readied by the PIO signifies that he/she has not filed the application bona-fide.

Under the above stated facts and circumstance the Commission hereby order;

- i) The Appellant to collect the information from the office of the PIO and report to the Commission about the information that he has received. And to be present in the next date of hearing without fail, **failing which this instant appeal will be heard and determined ex-parte.**

- ii) The PIO to provide the information to the Appellant and to be present in the next date of hearing without fail, **failing which necessary action will be initiated as per the provisions of RTI Act 2005.**
