**SUMMON**

**WHEREAS**, in connection with the **APIC-No. 108/2025**, your personal appearances required before the Commission on **19<sup>th</sup> March 2026 at 10:30 AM**. The **3<sup>rd</sup> hearing held on 6<sup>th</sup> November' 2025**. The Appellant Shri Mamu Sono, present during the hearing and the PIO found absent without intimation to the Commission the reason for his inability to attend the hearing, despite being present in the last hearing on **29/7/2025** and stating before the Court that all the information(s) are ready in his office and the Appellant may collect it from the his office.

**Heard the Appellant.**

The Appellant stated before the Commission, that after the second hearing held on **29/7/2025**, and the submission of the PIO before the Court that the information(s) are ready at his office, the Appellant personally went to the PIO's office but sadly the information(s) were not ready and till today the information have not been furnished to the Appellant by the PIO

Taking serious note of the failure of the PIO, to provide the information despite in the second hearing stating that all the information(s) are ready in his office but failed to provide them to the Appellant, the Commission had personally informed the PIO of the next date of hearing which is today and was ordered to be present without fail but the PIO has failed to provide the information(s) to the Appellant as well as failed to appear before the Court of the Commission without reasons intimated to this Commission which is unbecoming of a public authority who has to be reminded that he has got a statutory duty to attend the Court hearing when and appeal is preferred against him by Appellant/individuals, and hence the action of the PIO is taken as a contempt of the order of this Commission .

Under the above facts and circumstances the Commission hereby order;

- i) To send **warning summons** to the PIO-cum SPD, ISSE Itanagar Govt. of A.P, to provide all the information to the Appellant on or before the next date of

hearing without fail and to attend the next date of hearing without fail to answer the accusation of the Appellant. **Failing which, appropriate action shall be initiated against the PIO as per the provisions of the RTI Act, 2005.**

- ii) The Appellant to appear in person or through online mode before the Commission, in the next date of hearing. **Failing which his appeal shall be heard and determined ex-parte.**

Due to absence of the PIO, the Commission could not proceed the hearing of the appeal.

**The Commission ordered;**

**The next date of hearing be fixed on 19<sup>th</sup> march'2026 at 10:30 AM (Morning).**
