SUMMON

WHEREAS, in connection with the APIC-No. 730/2023, your personal appearance is required before the Commission on **28th April, 2026 at 02:30 PM**. The 4th hearing held on 3rd February 2026. The Appellant Shri Tamchi Gunte, found absent during the hearing and PIO-cum Project Director, DRDA Boleng, Siang District, is also absent during the hearing without intimating to the Commission the reason for his inability to attend the hearing, which is unbecoming on the part of the PIO, who has to be reminded that the PIO besides, public duties also has to attend Court hearing when an appeal is preferred against him as per the provisions of the RTI Act 2005, which is a statutory duty binding upon the PIO.

The Commission seriously viewed the absence of both the parties and hereby orders;

- i) To **issue summon** to the PIO to appear in person or through online mode before the Commission in the next date of hearing. **Failing which necessary action shall be initiated against the PIO as per RTI Act 2005.**
- ii) To **issue summon** to the Appellant to appear in person or through online mode before the Commission in the next date of hearing. **Failing which this appeal shall be heard and determined ex-parte.**

Due to absence of both the parties, the Commission could not proceed the hearing of the appeal.

The Commission ordered;

The next date of hearing be fixed on 28th April' 2026 at 2:30 PM
