## WARNING SUMMON

WHEREAS, in connection with the <u>APIC-No. 306/2024</u>, your personal appearance is required before the Commission on 17<sup>th</sup> JUNE, 2025 at 02:30 PM. The 2<sup>nd</sup> hearing held on 1<sup>st</sup> April 2025 related to the APIC No 306/2024. The Appellant Shri Sama Yangfo present during the hearing in person but the PIO-cum EE (RWD), Bameng Division East Kameng District, found absent without intimating to the Commission the reason for his inability to attend to the hearing, which is unbecoming on the part of the PIO, who has to be reminded that, the PIO besides public duties, also has to attend Court hearing when an appeal is preferred against him as per the provisions of the RTI Act 2005, which is a statutory duty binding upon the PIO.

Heard the Appellant.

The Appellant stated before the Commission that the PIO has not furnished any of the information(s) as sought by him in his form 'A' application till date.

After hearing the Appellant, the Commission seriously viewed the absence of the PIO and ordered;

- (i) To summon the PIO to appear in the person or through online mode before the Commission in the next date of hearing.
- (ii) The PIO to provide all the information(s) to the Appellant on or before the next date of hearing. Failing which necessary action shall be initiated against the PIO as per the provision of RTI Act 2005.
- (iii) The next date of hearing has been intimated to the Appellant. No formal notice required to be issued.

The Commission ordered;

The next date of hearing be fixed on 17<sup>th</sup> June' 2025 at 2.30 PM.
