ORDER

The 1st hearing held on **26th May' 2026'** related to the **APIC No-154/A/2026**. The Appellant Shri Bachunum Yun is present through online mode during the hearing before the Commission.

The PIO-cum-EE, PWD, Namsai Division, Namsai District, Govt. of Arunachal Pradesh is present through online mode during the hearing before the Commission.

Heard the Appellant;

The Appellant stated that the PIO has not provided him any information till now.

Heard the PIO;

The PIO stated that on receipt of the Form-A of the Appellant he had written a letter to the Appellant on 25th day of September' 2025 to deposit the fees for the information amounting to Rs. 620/- (rupees six hundred twenty only) for 310 pages of information, but the Appellant did not deposit the fees till now, further when the Appellant filed the first appeal before the First Appellate Authority (FAA) also the Appellant was told and asked to deposit the requisite fees but he did not deposit the same and again without depositing the fees and without collecting the information from the office of the PIO the Appellant has filed the Second Appeal at the Court of the Arunachal Pradesh Information Commission (APIC) in the form of Second Appeal.

The information are ready and had the Appellant deposited the fees the information by now could have been furnished to the Appellant, but for the failure of the Appellant to deposit the requisite fees in time, the information(s) are yet to be handed over to the Appellant.

After hearing both the parties the Commission hereby orders;

- i) The PIO to provide the information as sought by the Appellant completely and free of cost as the time limit provided under RTI, Act, 2005 for furnishing information has lapsed now.
- ii) The Appellant to collect the information from the office of the PIO and report to the Commission whether he has received the complete information or not.

- iii) The Appellant to be present in the next date of hearing without fail, failing which the Commission will presume that the Appellant has got the complete information from the PIO, and thereby, this appeal will be disposed of.
- iv) The PIO to be present in the next date of hearing to ascertain the receipt of the information by the Appellant and failing to attend the next hearing, the Commission will initiate action against the PIO as provided under RTI, Act, 2005.
- v) Notice for the next date of hearing need not be sent to both the parties as they are present during the hearing.

The Commission hereby orders;

The next date of hearing be fixed on 4th day of August' 2026 at 2:30 PM (Evening).
