Information sought:

The appellant filed RTI application dated 12.01.2023 seeking following information regarding name of Firm, tender Press Release, Name of Contractor, Work engagement, DPR, Fund utilization certificate, NIT details of payment, cheque/ demand draft, Photographs of the work if any: -

- a. C/O Ring Road of Koloriang Township (phase-1). ADA-2018-19.

- b. Augmentation and retrofitting of old DC Office koloriang K/Kumey District. CCI 2019-2020.
 - c. C/o Road from Koloriang to Mallapu. Additional RE (2018-19).
 - d. Special repair of circuit House at koloriang, Kurung Kumey District. SIDF 2019-2020.
 - e. C/o PWD Sub-Division Office Koloriang, SIDF & Additional (RE) 2018-19.
 - f. Maintenance and Renovation of various road under PWD Sub Division Koloriang Budget Estimate 2021-22.
 - g. C/o office cum Residential Complex at Koloriang Under SIB Itanagar.
- Period: As Project concerned.

Previous hearings:

First	:	On 13.10.2023, PIO absent & appellant present.
Second	:	On 15.12.2023, PIO is represented by Shri Manma Nikja & appellant present.
Third	:	On 12.04.2024, PIO absent & appellant absent.
Fourth	:	On 17.05.2024, PIO present & appellant present.
Fifth	:	On 29.08.2024, PIO absent & appellant present.
Sixth	:	On 09.12.2024, PIO absent & appellant present.

In Fifth hearing, *"The commission observes that the PIO, the Executive Engineer, Sangram Division PWD has not attended the last two hearings which appears to be deliberate. He has not responded to show cause notice dated 17.12.2024 issued to him. As required under para 41 of guidelines to the appellate authority, a repeat show cause notice shall be issued to the PIO, the Executive Engineer, PWD Sangram Division through the Chief Engineer, PWD Central Zone-A under intimation to the Principal Secretary, PWD, Govt. of Arunachal Pradesh who shall ensure implementation of provisions in the RTI Act.2005 by the concerned PIO.*

Relevant facts emerging during hearing:

The following were present:

Appellant	:	Present. He states that the PIO has not furnished the information irrespective of repeated order issued by this commission court including a show cause notice.
Respondent PIO	:	Absent.

Decision:

The commission after adverting to the facts and circumstance of the case, hearing the parties and perusal of the records, observes that PIO, EE, PWD Sangram

Division has not complied interim orders of this commission court. The PIO has not responded the **SHOW CAUSE NOTICE** dated 17.12.2024 issued to him.

Considering time constraint at the time of financial year end and since the PIO is absent in today's hearing, the PIO is given one more time for furnishing the information before imposition of penalty under Section 20 (1) of RTI Act, 2005. The PIO is directed to furnish the information to the appellant on or before **20th April 2025.**

Next date of hearing shall be fixed in due course of time.
