**ORDER/SUMMONS**

This is an appeal under Section\* 19(3) of RTI Act, 2005 received from Shri Pisa Tapam for non-furnishing of below mentioned information by the PIO, o/o the E.E (RWD), Layang Yangte Division, Kurung Kumey District, Govt. of Arunachal Pradesh as sought for by him under section 6(1) (Form-A) of RTI Act, 2005 vide his application dated 26.06.2025.

**a) Particulars of information:** To furnish the required information documents under (VVP) 2023-2024.

- 2) L021-Road from Nyolo to Buhan
- 2) L027-Rd from 2.5 Km Pt of Koloriang-Tabumhard to Sollung Tapin
- 3) L022 Road from Buyang to Chimpu
- 4) L023-Road from Buyang to Degging-1
- 5) L-028 Road from Buyang to Tate (Raktepu)
- 6) L026 - Road from Tabumha to Naji Bobok
- 7) L024 Road from BRTF road to Kachanjane
- 8) L025-Road from Nijubobok to Kiodhriang

**b) Details of Information: -**

- 1) Furnish technical sanction order copy
- 2) Form of Utilization certificate (UC)
- 3) Furnish the DPR copies of all the projects.
- 4) Furnish approve PFMS date in generated print payment to contractor.\*
- 5) Furnish the furnish the details Goods & Service Tax payment receipt copy with Memorandum of Payment Receipt and bill pass copy receipt and date.
- 6) Furnish details of running account bill with date and seal of accountant
- 7) Furnish the geo-tag report copy with MIS Report/Physically progress summary report/Field Executive details
- 8) Furnish details of technical bids and technical documents/tender documents/details of NIT publish paper.

- 9) Furnish details of site visit report copy with site inspection report and final inspection and approval copy.,
- 10) Furnish details of Performance Guarantee/Bank Guarantee bond copy
- 11) Furnish detail approval for Tender Evaluation Committee
- 12) Furnish details of actual measurement book with contains or area, book No. and page wise bill.
- 13) Furnish work order copies of each project issued to contractors from department.
- 14) Furnish the contractor and department agreement copy.
- 15) Furnish the guidelines/govt. order/circular under VVP scheme.
- 16) Furnish the details of payment made to contractor under VVP scheme of each project from the department.
- 17) Furnish details of T& Ps deployed at each project site by the contractor.
- 18) Furnish NOC from Land Owner of each project
- 19) Furnish the details royalty, govt. revenue and other tax amount paid to government account of each project.
- 20) Furnish the colour photograph of work starting to ending with geo-tag Colour copy
- 21) Furnish the details of mobilization charges paid/payment to contractor while starting of work of each project under VVP scheme.
- 22) Furnish the account details of department and fund received from the government for payment of running bill to contractor.
- 23) Furnish the Certified True copy of each document from PIO.

**Brief facts emerging from the appeal:**

Records emerging from the appeal disclose that the Appellant, Shri Pisa Tapam had requested the PIO for the aforementioned information / documents but failed to obtain the same which prompted him to appeal before the Chief Engineer RWD (W/Z) Govt. of Arunachal Pradesh, Itanagar as the First Appellate Authority (F.A.A) under Section 19 (1) of the RTI Act vide his Appeal Memo dated 23.08.2025.

Records further reveal that the APIO-cum-AE Er. K Welly vide his letter dtd. 2<sup>nd</sup> Sept. 2025 had requested the FAA/CE (PMGSY), RWD, Itanagar to furnish the sought for information as the project mentioned in the form-A of RTI application are VVP project and comes under his jurisdiction. The letter of AE/APIO addressed to the FAA/CE (PMGSY), RWD, Itanagar is reproduced below :

"Sir,

*RTI application to the FAA received from Shri Pisa Tapam, Add- Dokum colony, PO/PS-Naharlagun, Papumpare District, Arunachal Pradesh. The projects mentioned in the Form A RTI application are VVP projects and comes under your jurisdiction. Therefore, I am directed to forward herewith the RTI application to your good office.*

*This is for your information & necessary action please.*

But the appellant, apparently, failed to receive a positive response from the PIO and FAA and therefore, filed his 2<sup>nd</sup> appeal before this Commission under section 19(3) of the RTI Act vide Memo of Appeal dt.17.10.2025.

**Hearing and decision :**

The appeal is, accordingly, listed for hearing today on 06.03.2026 wherein Er. Shri Yangbiu Loka, AE-cum-APIO is present in person while the appellant, Pisa Tapam attended through VC.

The appellant, reiterating his demand for the requested information/documents from the PIO, pleaded for an appropriate direction to the PIO to furnish information. On the other hand, the APIO submitted that the documents pertaining to this appeal are with the Koloriang Division as the particulars of schemes mentioned in the RTI application of the appellant comes under the jurisdiction of PIO, o/o the RWD, Koloriang Division. In this regard the APIO also produced a copy of letter dt. 3<sup>rd</sup> February, 2026 (extracted below) requesting this Commission to transfer the appeal in question to the PIO, o/o the EE, RWD Koloriang Division.

“Sir,

*With reference to an appeal case U/S 19(3) of RTI Act, 2005 vide case No. APIC-790/2025 dated Itanagar, the 16<sup>th</sup> February, 2026.*

*It is to inform you that the RTI sought by one appellant Shri Pisa Tapam, regarding the furnishing of details information mentioned in the Form-A of RTI Act, 2005 in his application. The particular mentioned schemes are comes under the jurisdiction of PIO, o/o the RWD Koloriang Division of Kurung Kumey District, (A.P). Since the RWD Koloriang Division has been bifurcated from this division(RWD) Laaying Yangte division on October, 2025.*

The PIO, o/o the E.E(RWD), Laying Yangte Division and the PIO o/o the E.E (RWD), Koloriang Division Koloriang Division are, therefore, directed to be present in the next hearing fixed on 22<sup>th</sup> April, 2026 with records / evidence of handing over and taking over of the charges of records/documents pertaining to schemes falling under the jurisdiction Koloriang Division.

**NOW THEREFORE**, you are hereby summoned to appear in person or online in the Hon'ble Court of Shri Sangyal Tsering Bappu, SIC on 22<sup>th</sup> April, 2026 2026 (Wednesday) at 10.30 am to answer the claims, and you are directed to produce on that day all the documents upon which you intend to rely in support of your claims/defense.

Take notice that, in default of your appearance, on the day above- mentioned, the matter will be heard and determined in your absence.
