**ORDER**

This is an appeal under Section 19(3) of RTI Act, 2005 filed by Shri Tamchi Gungte, Near KV2 School, Chimpu Itanagar, District Papum Pare, Arunachal Pradesh, for non-furnishing of information by the SPIO-cum-EE(Hydro Power), Govt. of A.P., Hydro Power Division DHPD, Anini Dibang Valley District, Arunachal Pradesh as sought by the Appellant under section 6(1) of RTI Act, 2005 vide Form-A Dated 25/04/2023 regarding Construction of Common Service Centre (CSC) at Roing in Roing MCA (Hq) of Lower Dibang Valley Dist. A.P.

**The 4<sup>th</sup> hearing is held today on 14<sup>th</sup> March, 2024 as scheduled.** Shri Ojing Nobeng, the PIO-cum-EE(Hydro Power), Govt. of A.P., Hydro Power Division DHPD, Anini, Dibang Valley District, Arunachal Pradesh and the Appellant Shri Tamchi Gungte are absent. The PIO has submitted a copy of letter No. AHPD/DHPD/W-30/2023-24/76-80 Dated 07/07/2023 with receipt and signature of appellant Shri Tamchi Gungte dated 23/02/2024. However, the PIO has not mentioned anything about furnishing of the information to the appellant nor the appellant has intimated the commission of his receipt of information. Since, the both are absent, the commission could not hear from them. The commission giving reasonable opportunity to both the parties decides to fix one more date of hearing. The court is adjourned for next date of hearing.

Both the parties are directed to appear before the commission's court on the next date of hearing. In case the PIO remains absent without any reasonable prior intimation the penal provision under section 20(1) of the RTI Act 2005 shall be imposed on him. In case the Appellant remains absent again, the case shall be disposed of without any further notice presuming that the Appellant has received information and is satisfied with the information furnished by the SPIO. The court is adjourned for the next date of hearing.

**The next date of hearing is fixed on 9<sup>th</sup> May,2024 (Thursday) at 02:00PM.**

**Therefore, Shri Ojing Nobeng, the PIO-cum-EE(Hydro Power), Govt. of A.P., Hydro Power Division DHPD, Anini, Dibang Valley District, Arunachal Pradesh is hereby summoned to appear before this Court in person on the scheduled date and time without fail.**
