ORDER/SUMMON

This is an appeal under Section 19(3) of RTI Act, 2005 received from Shri Toku Tapam for non-furnishing of below mentioned information by the PIO, o/o the District Fishery Officer (DFDO), Kra Daadi District as sought for by him under section 6(1) (Form-A) of RTI Act, 2005 vide his application dated 07.07.2025.

Details of information required:

- 1) Sanction order No. Fish/Dev/M-137/92-93/26 dated 25.08.2023 for construction of 150 Ha integrated commercial fish ponds in Kra Daadi. District (development of Inland Aquaculture (CSS, GIA);
- 2) Sanction order No. Fish/Dev/M-137/92-93/27 dated 25.08.2023 for construction of 100 Ha integrated commercial fish ponds in Kra Daadi District (development of Inland Aquaculture (CSS, GIA);
- 3) Sanction order No. Fish/Dev/M-137/92-93/3 dated 25.08.2023 for construction of 130 Ha integrated commercial fish ponds in Kra Daadi District (development of Inland Aquaculture (CSS, GIA);
- 4) Sanction order No. Fish/Dev/M-137/92-93/40 dated 25.08.2023 for construction of 120 Ha integrated commercial fish ponds in Kra Daadi District (development of Inland Aquaculture (CSS, GIA);

- 11) Sanction order No. dated 17,10.2023 for Fish/Dev/NESIDS-122-23/61 construction of 140 Ha Domestic fish ponds in Kra Daadi District (NESIDS, GIA);
- 12) Utilization certificates;
- 13) photographs of fish pond with location;
- 14) Names of beneficiaries;
- 15) Name of the contractors and
- 16) Pay roll and any other relevant documents.

Facts emerging from the appeal.

Records emerging from the appeal disclose that the appellant, Shri Toku Tapam had requested the PIO for the aforementioned information / documents in response to which the PIO-cum-DFDO, Kra Daadi District, Palin Shri Pani Odyssey, vide his letter dt. 27th August, 2025 informed the appellant that there is no relevant documents in the department as sought in his application. Dissatisfied with the reply from the PIO the appellant filed his 1st appeal before the Director of Fisheries (HQ), Itanagar, the First Appellate Authority (FAA) under Section 19(1) of the RTI Act. vide his appeal Memo dated 26.08.2025.

However, the appellant having failed yet again to obtain the information preferred 2nd appeal before this Commission under Section 19 (3) of the RTI Act, 2005 vide Memo of appeal dt. 24.10.2025.

This appeal was, accordingly, listed on 11th March, 2025 but none of the parties appeared. This Commission, therefore, viewing seriously, the non-appearance of the appellant in particular, closed this appeal for non-prosecution presuming that the appellant is no longer interested in pursuing the appeal.

However, on 13.04.2026, this Commission received letter dt.12.03.26 (as reproduced below) from the appellant, Shri Toku Tapum complaining that he did not receive the summon notice dt.16.02.26 for hearing fixed on 11.03.26 and pleaded for listing the appeal again.

“Respected Sir,

Most respectfully I beg to state that I am the appellant/complainant in the above-mentioned RTI case pending before this Hon'ble Commission.

That the notice of hearing dated 11.03.2026 in the said case was not served upon me, and therefore I had no knowledge about the date fixed for hearing.

That due to non-service of notice, I could not appear before this Hon'ble Commission on the scheduled date.

It is therefore most humbly prayed that this Hon'ble Commission may kindly not dismiss the case for non-appearance and may be pleased to fix another date for hearing, in the interest of justice.

For this act of kindness, I shall remain grateful.
