ORDER

This is an appeal under Section 19(3) of RTI Act, 2005 filed by Shri Palen Laa & Smti Yukar Yaga, c/o Jullang near Sonam Nursery, Po/Ps-Itanagar, Papum Pare District, Arunachal Pradesh, for non-furnishing of information by the PIO-cum-DHO, Govt. of A.P., O/o District Horticulture Officer, Raga, Kamle District, Arunachal Pradesh as sought by the Appellant under section 6(1) of RTI Act, 2005 vide Form-A Dated 30/06/2023 regarding Atmanirbhar Bhagwani Yojana Scheme entire Raga District Kamle.

The 1st hearing is held today on 30th January, 2024 as scheduled. Shri Komri Murtem, the PIO-cum-DHO, Govt. of A.P., O/o District Horticulture Officer, Raga, Kamle District, Arunachal Pradesh is present. The Appellant Shri Palen Laa is absent, however he has submitted a letter stating that due to a judicial court hearing at JMFC Daporijo on 31st January, 2024 he won't be able to attend the hearing. The PIO submitted that the appeal case was disposed by the First Appellate Authority (FAA) with the direction to the PIO to furnish information. In compliance with direction of the FAA the PIO has prepared all the documents for furnishing to the Appellant but the appellant has not reported for collection of the same. However, he has submitted that he has brought the document to be furnished to the Appellant, but could not as the appellant is absent.

The Commission directs the appellant to visit the office of the PIO and collect information from him latest by 15th February, 2024 and intimate the commission about his findings after verifications of the documents so collected from the PIO.

Both the parties are directed to appear before the Commission's court on the next date of hearing without fail. If the SPIO is found absent the Commission may initiate penal action as per provision under section 20(1) of the RTI Act-2005 and in case Appellant is found absent the case shall be disposed of without any further notice, presuming that the Appellant is satisfied with the information so furnished.

The next date of hearing is fixed on 23rd April, 2024 (Tuesday) at 1030 hrs.

Therefore, the PIO-cum-DHO, Govt. of A.P., O/o District Horticulture Officer, Raga, Kamle District, Arunachal Pradesh is hereby summoned to appear before this Court in person on the scheduled date and time without fail.
