**SUMMON**

**WHEREAS**, in connection with the APIC-No. 198/2025, your personal appearance is required before the Commission on **14<sup>th</sup> April, 2026 at 02:30 PM**. The 3<sup>rd</sup> hearing held on **15<sup>th</sup> January' 2026**. Both the parties are absent without informing to the Commission, the reasons for their inability to attend the hearing.

Due to non presence of the parties the Commission could not proceed the hearing and fixed another date for hearing of this instant appeal.

It is to be noted that, today the date was fixed for ascertaining from the Appellant, the receipt of the information(s) from the PIO which was to be collected by the Appellant in person from the office of the PIO as ordered by the Commission on 18.09.2025.

But in the absence of the Appellant the Commission is not clear whether the PIO has provided the information to the Appellant and whether the Appellant had gone to the office of the PIO to collect the information(s).

In order to ascertain the above the Commission hereby orders;

1. The Appellant to be present in the next date of hearing to ascertain whether he has received the information(s) from the PIO's office by personally presenting himself at the office of the PIO to collect the information(s).
2. In the event of the absence of the Appellant in the next date of hearing this instant appeal will be heard and determined ex-parte.
3. The PIO to be present in the next date of hearing to submit before the Commission whether he has given the complete information(s) to the Appellant.
4. Notice for the next date hearing be served to both the parties.

**The next date of hearing be fixed on 14<sup>th</sup> day of April' 2026 at 2:30 PM (Evening).**
