ORDER

This is an appeal under Section 19(3) of RTI Act, 2005 filed by Shri Koti Mize, Village Riga, PO-Riga, PS-Boleng, Siang District, Arunachal Pradesh, for non-furnishing of information by the SPIO-cum-DPDO, Govt. of A.P., Boleng, Siang, District, Arunachal Pradesh as sought by the Appellant under section 6(1) of RTI Act, 2005 vide Form-A Dated 04/05/2023 regarding 14th & 15th Finance Commission.

The 3rd hearing is held today on 14th March, 2024 as scheduled. Shri Jacob Tabing, the SPIO-cum-DPDO, Govt. of A.P., Boleng, Siang, District, Arunachal Pradesh, in compliance with the direction issued on 23rd February, 2024 is present along with the member secretaries, viz. Shri Niyang Pertin, Member secretary-cum-CO Panging, Govt. of A.P., Siang, District, Arunachal Pradesh, and, Ms. Mihin Sonia, Member secretary-cum-CO Riga, Govt. of A.P., Siang, District, Arunachal Pradesh. The appellant Shri Koti Mize is present. The PIO handed over a bunch of documents to the appellant claiming to be the information sought by the appellant. After receiving the information as furnished, the appellant sought time for its verification and assured the commission to inform his findings within one week time from the date of issue of this order. For compliance of the directions, the commission decides to fix a new date for hearing. The court is adjourned for next date of hearing.

Both the parties are directed to appear before the Commission's court on the next date of hearing without fail. If the PIO is found absent the Commission may initiate penal action as per provision under section 20(1) of the RTI Act-2005 against the PIO and in case Appellant is found absent the case shall be disposed of without any further notice, presuming that the Appellant is satisfied with the information so furnished.

The next date of hearing is fixed on 4th April, 2024 (Thursday) at 02:00PM.

Therefore, Shri Shri Jacob Tabing, the SPIO-cum-DPDO, Govt. of A.P., Boleng, Siang, District, Arunachal Pradesh, is hereby summoned to appear before this Court in person on the scheduled date and time without fail.
