ORDER

This is an appeal under Section 19(3) of RTI Act, 2005 filed by Adv. Ganpho Khusumchai, Medical colony Longding, Po/Ps-Longding, Longding District, Arunachal Pradesh, for non-furnishing of information by the SPIO-cum-EE (RWD), Govt. of A.P., Longding, Longding District, Arunachal Pradesh as sought by the Appellant under section 6(1) of RTI Act, 2005 vide Form-A Dated 03/02/2022 regarding Construction of two (2) teacher quarters under DOTCL at Khasa village.

The 2nd hearing is held today on 23rd February, 2024 as scheduled. The Appellant Adv. Ganpho Khusumchai is present, the representative of the PIO-cum-EE (RWD), Govt. of A.P., Longding, Longding District, Arunachal Pradesh Shri J. Jini, JE(RWD) appeared in the court after the departure of the Appellant. The Appellant had submitted that the PIO has not furnished with the information as directed by the commission during the 1st hearing held on 16th January, 2024.

The representative of the PIO appearing late in the court room submitted that the information was furnished to the Appellant through registered post and he had shared counter slip of the postal service dated 06/02/2024 to the appellant. He has also submitted that he has brought information in hard copy to furnish directly to the Appellant. The Appellant had already left, so the Commission directed the APIO to hand over the information to the Appellant. The APIO agreed to do so. The Appellant is hereby directed to collect information from the PIO and intimate to the commission of his findings. The Commission to hear from the Appellant decides to fix one more date of hearing.

Both the parties are directed to appear before the Commission's court on the next date of hearing without fail. If the SPIO is found absent the Commission may initiate penal action as per provision under section 20(1) of the RTI Act-2005 and in case Appellant is found absent the case shall be disposed of without any further notice, presuming that the Appellant is satisfied with the information so furnished.

The next date of hearing is fixed on 14th March, 2024 (Tuesday) at 1030 hrs.

Therefore, the SPIO-cum-EE (RWD), Govt. of A.P., Longding, Longding District, Arunachal Pradesh is hereby summoned to appear before this Court in person on the scheduled date and time without fail.
