**SUMMON**

**WHEREAS**, in connection with the **APIC-No. 05/2026 (C)**, your personal appearance is required before the Commission on **24<sup>th</sup> September 2026 at 10:30 AM**. The 1<sup>st</sup> hearing held on **14<sup>th</sup> day of July' 2026'**. The Complainant Shri Tania June is present during the hearing before the Commission.

- iii) The Complainant to be present in the next date of hearing without fail, failing which this Commission will presume that the Complainant has received the complete information(s) from the PIO, and thereby, this appeal will be heard and determined ex-parte, by way of disposing of this appeal.
- iv) Send notice for the next date of hearing to the PIO of the office of the Director, Department of Administrative Training Institute, Naharlagun, Govt. of Arunachal Pradesh.

- v) Notice of the next date of hearing need not be sent to the Complainant as he is present during the hearing.

**The next date of hearing be fixed on 24<sup>th</sup> day of September' 2026 at 10:30 AM (Morning).**
