**ORDER**

This is an appeal under Section 19(3) of RTI Act, 2005 filed by Shri Palen Laa & Smti Yukar Yaga, c/o Jullang near Sonam Nursery, Po/Ps-Itanagar, Papum Pare District, Arunachal Pradesh, for non-furnishing of information by the SPIO-cum-EE(RWD), Govt. of A.P., Raga Division, Kamle District, Arunachal Pradesh as sought by the Appellant under section 6(1) of RTI Act, 2005 vide Form-A Dated 28/06/2023 regarding Road from Liruk to Jigi Village, Package NO. AR/25/01/018 Length-16.50 km, Cost Rs. 1426.26 Lakh.

**The 1<sup>st</sup> hearing is held today on 6<sup>th</sup> February, 2024 as scheduled.** The SPIO-cum-EE(RWD), Govt. of A.P., Raga Division, Kamle District, Arunachal Pradesh is represented by Shri Buru Sambio, UDC. The Appellant Shri Palen Laa is present. The representative of the PIO has submitted that in compliance with the direction of the Commission on 16<sup>th</sup> January, 2024 the PIO collected all the information and kept ready to furnish the same to the Appellant. The Appellant has failed to collect the information. The documents brought by the PIO IS handed over to the Appellant. The Appellant after receiving the document appealed the Commission to give time for verification of the same.

The Commission considering the Appeal of the Appellant grants fifteen days' time for verification. If any short fall found in furnishing of information the Appellant is directed to submit the specific list of information to the PIO which are found incomplete. The PIO is directed to furnish complete, correct and authenticated information within seven days from the receipt of the list from the Appellant. The action taken report should be intimated to the Commission.

Both the parties are directed to appear before the Commission's court on the next date of hearing without fail. If the SPIO is found absent the Commission may initiate penal action as per provision under section 20(1) of the RTI Act-2005 and in case Appellant is found absent the case shall be disposed of without any further notice, presuming that the Appellant is satisfied with the information so furnished.

**The next date of hearing is fixed on 9<sup>th</sup> April, 2024 (Tuesday) at 1030 hrs.**

**Therefore, the SPIO-cum-EE(RWD), Govt. of A.P., Raga Division, Kamle District, Arunachal Pradesh is hereby summoned to appear before this Court in person on the scheduled date and time without fail.**
