SUMMON.

WHEREAS, in connection with the **APIC-No. 634/2025**, your personal appearance is required before the Commission on **22nd October, 2026 at 10:30 AM**. The 2nd hearing held on **13th August' 2026**. The Appellants Shri Passang Kassung and John Tara Bakey are absent without reporting the reason for their absence to the Commission despite notice for today's hearing issued to them on 27th November' 2025 at their address as given in their Form-A.

The PIO-cum-Assistant Scientific Officer, Shri Aje Dolo, office of the Centre for Earth Science and Himalayan Studies, Govt. of Arunachal Pradesh is present during the hearing before the Commission.

Heard the PIO;

The PIO stated that the Form-A of the Appellants are not specific and not clear about the information(s) that they have applied, and their Form-A is vague and even if the Form-A is considered the information(s) will be too voluminous that will constraint the resources of the PIO's office as the Govt. of Arunachal Pradesh does not provide separate and adequate funds to the department to spend on papers, ink and other tools to provide bulk information to the information seekers.

The PIO stated that he will write to the Appellants why the office of the PIO cannot be providing the information(s) in the present format that the Appellants have applied.

After hearing the PIO and in the absence of the Appellants the Commission hereby orders as below;

- i) Warning Summons be issued to the Appellants to be present in the next hearing without fail, failing which this appeal will be heard and determined ex-parte, by way of disposing this appeal.

- ii) The PIO to be present in the next date of hearing without fail, failing which necessary action as provided under RTI, Act, 2005 will be initiated against the PIO.
- iii) Send notice for next date of hearing to the Appellants.
- iv) Notice for the next date of hearing need not be sent to the PIO as he is present during the hearing.

The Commission hereby orders;

The next date of hearing be fixed on 22nd day of October' 2026 at 10:30 AM (Morning).
