**WHEREAS**, in connection with the APIC-No. 461/2025, your personal appearance is required before the Commission on **16<sup>th</sup> April, 2026 at 10:30 AM**. - ii) In the failure of the Appellant to attend the next date of hearing, the **Commission will hear and determine this appeal ex-parte**.
- iii) The PIO to be present in the next date of hearing without fail to ascertain the receipt of the information that have been sent by him to the Appellant through registered post.
