The 1st hearing was held on 24th September 2025 related to the APIC No-563/A/2025(Appeal). The appellant Shri Chow Lajamang Mannow attended the hearing through VC but the PIO-cum-EE (PWD), Kanubari Division found absent without any intimation to the Commission.

As per the case record, it is seen that the First Appellate Authority has given notice dated 23/04/2024 to the PIO-cum-EE(PWD), Kanubari Division directing to do necessary action and intimate to the First Appellate Authority within 15 (fifteen) days on receipt of the letter. It is also seen that the PIO has written a letter addressed to the appellant Chow Lajamang Mannow to deposit a Treasury Challan demand draft in favour of the EE(PWD), Kanubai Division of Rs. 18,34/- only as the information sought by him has been prepared and ready in the Division.

The FAA has written a letter to the PIO-cum-EE (PWD), Kanubari Division to provide available information/documents free of cost as the PIO failed to respond within stipulated time period of 30 days under RTI Act, 2005.

The PIO is directed to be present in person before the Commission in the next date of hearing and also directed to provide the information as per Form 'A' application free cost on or before next date of hearing if not exempted under the RTI Act. Failing which necessary action shall be initiated against the PIO as per the RTI Act, 2005.

The Commission fixed next date of hearing on 08/12/2025 at 1030 hours,
