**An Appeal Case U/S 19(3) of RTI Act, 2005**

### ORDER/SUMMONS

This is an appeal under Section 19(3) of RTI Act, 2005 received from Shri Nyake Bojir and Sri Kijum Doke for non-furnishing of below mentioned information by the PIO, o/o the E.E (RWD), Basar Division, Leparada District (A.P) as sought for by them under section 6(1) (Form-A) of RTI Act, 2005 vide their application dated 02.07.2025:

**A) Particular of information:** Untied Fund during 2024-25

**B) Details of information required:**

1. True certified copies of the total amount received under the Untied Fund during 2024-2025.
2. A copy of the sanction letter with approval under the Untied Fund for 2024-2025.
3. Full details of the amount spent/utilized from the Untied Fund during 2024-2025.
4. A copy of the total details and estimated cost for each work.
5. Copy of all work orders.
6. True certified copies of geo-tagging details for all the mentioned projects.
7. True certified copies of DPR/GFR along with video and photography evidence before and after the completion:
  - a. Restoration of slip clearance at PMGSY road to Galu.
  - b. Restoration of slip clearance at BRTF road to Pagi.
  - c. Restoration of slip clearance at BRTF road to Nyodu.
  - d. Restoration of slip clearance at PWD road to Tare.
  - e. Restoration of slip clearance at Old Dari to Hido.
  - f. Restoration of slip clearance at Pagi to Disi.
  - g. Restoration of slip clearance at ALB Road to Govt Model College Basar.
  - h. Restoration of slip clearance at Deke to Yordo.
  - i. Restoration of slip clearance at Tai to Liromoba.
  - j. Construction of approached road at Chemte, Taba village

8. True certified copies of DPR/GFR along with video and photography evidence before and after the completion of the project.
9. True certified copies of geo-tagging details for the mentioned project.
10. True certified copies of any instructions, orders, or directives issued by the Deputy Commissioner, Basar, for the proper execution of contracts for the above-cited projects.
11. True certified copies of any modifications to the project, including any instructions or orders issued by the concerned department to the contractor from time to time.
12. Furnish certified copies of certificates regarding mandatory deductions of GST, royalty, Labourecess, income tax, etc., and details of specific treasury challans bearing the head of account deposited in the exchequer.
13. A copy of the Utilization Certificate (UC) for the works mentioned above.
14. A copy of the bill challan for all the above-mentioned projects.
15. A copy of the NIT plot.
16. If payment was made through PFMS, please provide a copy of the PFMS-generated print payment details.
17. A copy of the work completion certificate.
18. 18. A copy of the name of the firm with proprietor details.
19. 19. A copy of the cheque counterfoil and payment details.
20. The concerned PIO should reply all above-mentioned points in affidavit.

**C) Period for Information asked for: 2024-2025**

**Brief facts emerging from the appeal :**

Records emerging from the appeal disclose that the appellants had requested the PIO for the aforementioned information / documents but failed to obtain the same which prompted them to appeal before the Superintending Engineer (RWD), Govt. of A.P. Basar, the First Appellate Authority under Section 19 (1) of RTI Act, 2005 vide Memo of Appeal dt.11.08.2025. However, no records have been placed as to the hearing conducted, if any, by the FAA. But the appellants preferred their 2<sup>nd</sup> appeal before this Commission under Section 19 (3) of the RTI Act. 2005 vide Memo of appeal dt. 02.09.2025 enclosing therewith point-wise replies furnished by the PIO upon perusal of which, this Commission observes/notices as under:

As already noticed above, the left out information are not exempted under any of the exemption clauses. And as such, the PIO is directed to furnish those left out information and/or appropriate replies by way of an affidavit to the appellants within 4(four) weeks from the date of receipt of this order and report compliance thereof on 30.01.2025, the next date of hearing.

**NOW THEREFORE**, you are hereby summoned to appear in person or online in the Hon'ble Court of Shri Sangyal Tsering Bappu, SIC on the 30<sup>th</sup> January, 2026 (Friday) at 2 pm to answer the claims, and you are directed to produce on that day all the documents upon which you intend to rely in support of your claims/defense.

Take notice that, in default of your appearance, on the day above- mentioned, the matter will be heard and determined in your absence.
