The 4th hearing was held on 29th July, 2026 related to the APIC No-615/A/2025 (Appeal). Appellants Shri Gollo Paso present in person but the PIO-cum-DDSE, Papum Pare District found absent without any intimation.

As per the order date 06/05/2026, PIO-cum-DDSE, Papum Pare District has stated before the Commission that information sought at Sl. No. 4,5,6 & 10 are with the DDSE, Kurung Kumey who is the appointing authority. Relying upon the statement made by the DDSE, Papum Pare, the Commission directed the PIO to transfer the sought information to DDSE, Kurung Kumey under Section 6 (3) (ii) of the RTI Act, 2005.

Today the PIO-cum-DDSE, Papum Pare is absent and has not made any intimation to the Commission whether he has transferred the sought information to DDSE, Kurung Kumey. PIO, Yupia is once again directed to immediately transfer/forward the sought information to the DDSE, Kurung Kumey District if it is not available with him.

The PIO-cum-DDSE, Papum Pare is also directed to intimate to the Commission whether he has forwarded the sought information to DDSE, Kurung Kumey on or before next date of hearing.

Commission fixed next date of hearing on 09/09/2026 at 2 PM.
