ORDER/SUMMON

This is an appeal under Section 19(3) of RTI Act, 2005 received from Shri Nabam Tadap for non-furnishing of 14(fourteen) point information regarding c/o Approach road from Airport to Hollongi Mik Village by the PIO, o/o the EE (PWD), Doimukh Division, Papum Pare district as sought for by him under section 6(1) (Form-A) of RTI Act, 2005 vide his application dated 15.09.2025.

This appeal was accordingly, heard on 10.06.2026 wherein the appellant, Shri Nabam Tadap was present in person while the PIO, Er. Shri Naresh Teli Camdir, EE appeared through VC.

This Commission, upon hearing the parties and on perusal of the documents / information furnished by the PIO as per the list of information as sought for by the appellant, had noticed as under:

This Commission, considering the mandate of the RTI Act, 2005, directed the PIO to furnish the left out information /documents or an appropriate replies with cogent reasons on affidavit to those queries wherever the information are denied. The PIO was also directed to comply with this direction within 1(one) month from the date of receipt of this order and report the compliance therewith to this Commission for further consideration of the appeal.

In compliance with the order of this Commission as above, the PIO, vide letter dt.15.06.2026, has furnished the following replies:

The appellant, however, vide his letter dt.17.07.2026 (as reproduced hereunder) has complained that the PIO did not comply with the order of this Commission and therefore, pleaded for appropriate action against the PIO under the relevant provisions of RTI Act, 2005:

"Respected, Sir,

I respectfully submit that, despite Hon'ble state Information Commission Order passed Dated on 10.06.2026 I have not received any response or communication from concerned Public Information Commission (PIO) and First Appellate Authority (FAA) regarding my RTI application and the subsequent first appeal.

The continued non-response by both the PIO and the FAA amounts to non-Compliance with provisions of the Right to Information Act, 2005, and has caused unnecessary delay in the disposal of my matter.

I therefore, respectfully bring this fact to the notice of the Hon'ble commission and request that the non-Compliance of the concerned authorities be taken on record and that appropriate action be taken in accordance with the provisions of the Right to Information Act, 2005.
