Information sought:

The appellant filed an RTI application dated 10.09.2024 seeking following information regarding C/o "Integrated infrastructure Development for Tourism at Tawang with the provision of sewage and water treatment plant at Tawang District, under the North East Special Infrastructure Development Scheme (NESIDS) in Arunachal Pradesh during the financial year 2020-21.

Particulars of sought information:

1. Furnish the Certified Sanction Order Copy of the total list of project mention above.

- 2. Furnish the total lists of Work Components of the Projects.
- 3. Furnish the certified copy of Notice Inviting Tender (NIT) with respect to the subject mention above.
- 4. Furnish the Certified copy of Newspaper in which the NIT was Published (at least 3 Newspaper name (one national & 2 locals) along with the date of publication of newspaper as per Govt. approved order.
- 5. Furnish the Tender Evaluation copy (Technical Bid) along with the list of Firms participated in the tender processed for the work.
- 6. Furnish the Name of Firm who won the tender work with respect to the subject mention above.
- 7. Furnish the certified copy on which Date the project has been started.
- 8. Furnish the Geo Coordinate information for the work mentioned above.
- 9. Furnish the certified full agreement copy made in between the executing agency and the firm owner.
- 10. Furnish the certified copy of Contractor Registration of the winning firm.
- 11. Furnish the certified copy of Contractor Enlistment update reports, of tender winning firm.
- 12. Furnish the certified Affidavit copy Sworn before a Competent Magistrate to the effect that he/she does not have 2 (Two) or more incomplete ongoing commitment (projects/contract to execute) at the time of bidding by the tender participant and winning firm. (as per rule SPWD/W-66/2012 Dtd. 01-08-2018).
- 13. Furnish the certified copy of declaration letter from the contractor (if the tender participant is from different state) to the effect that he/she has not been debarred from tendering by authority in which contractor is registered (As per CPWD Work Manual 2014, Section 15.2.3(2)).

The PIO shall dispose of such written representation when received within two weeks from the date of receipt under intimation to this commission.

In case no compliance report of this order received in the commission from the PIO and appellant within specified time mentioned herein above, this appeal case shall be closed without further hearing.

Hearing adjourned. Next date of hearing shall be fixed after receipt of compliance report of this order from PIO and Appellant.
