## **SUMMON**

- ii) The Appellant to be present in the next date of hearing without fail and also to approach the office of the PIO for collecting the remaining information(s) which have not been furnish to him by the PIO.
- iii) Issue summons to the PIO to be present in the next date of hearing without fail.

iv) Notice need not be send to the Appellant as he is present during the hearing before the Commission.

The next date of hearing be fixed on 8th January' 2026' at 10:30 AM (Morning).
